1) Revise PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION, Article 2. Basis of Selection:

DELETE: The total aggregate evaluated amount for each bid is calculated by multiplying the unit price for each item by the associated estimated quantity listed and summing the values. **It is mandatory for bidders to provide pricing for a minimum of 56 of the 70 items to be considered compliant.** The evaluation will be based on like items.

INSERT: The total aggregate evaluated amount for each bid is calculated by multiplying the unit price for each item by the associated estimated quantity listed and summing the values. **It is mandatory for bidders to provide pricing for a minimum of 56 technically compliant items (out of the 70 items requested) to be considered compliant.** The evaluation will be based on like items.

Completion of the Minimum Mandatory Specification is mandatory to be deemed compliant.
