The purpose of this amendment is to make an administrative change to Section 3.1 of this TBIPS SA RFP.

THE FOLLOWING AMENDMENT FORMS PART OF THIS TBIPS SA RFP.

1) At Section 3.1 BID PREPARATION INSTRUCTIONS:

Delete:

Canada requests that Bidders provide their bid in three separate attachments, as follows, to be contained in their e-mail bid submission:

- (i) Section I: Technical Bid
- (ii) Section II: Financial Bid
- (iii) Section III: Certifications

Insert:

- (a) Unless the RFP specifies otherwise, Canada requests that Bidders provide their bid in separate sections as follows:
 - (i) Section I: Technical Bid (1 paper copy and 2 CD copies)
 - (ii) Section II: Financial Bid (1 paper copy and 1 CD copy)
 - (iii) Section III: Certifications (1 paper copy)

Where a CD copy is required, if there is a discrepancy between the wording of the CD copy and the paper copy, the wording of the paper copy will have priority over the wording of the CD copy. Prices must appear in the financial bid only. Prices must not be indicated in any other section of the bid.

- (b) Canada requests that Bidders follow the format instructions described below in the preparation of their bid:
 - (i) use 8.5 x 11 inch (216 mm x 279 mm) paper;
 - (ii) use a numbering system that corresponds to the bid solicitation;
 - (iii) include a title page at the front of each volume of the bid that includes the title, date, bid solicitation number, Bidder's name and address and contact information of its representative; and
 - (iv) Include a table of contents.
