**Question 1 :**

We would like to request a one-week delay in the delivery of the proposal in order to finalize the teaming required to best serve Canada.

**Answer 1 :**

See point 1 of the current amendment.

**Question 2:**

In Part 4 section 1.1 technical evaluation, it is mentioned that "Except where expressly provided otherwise, the experience described in the bid must be the experience of the Bidder itself (which includes the experience of any companies that formed the Bidder by way of a merger but does not include any experience acquired through a purchase of assets or an assignment of contract)." Since it is unlikely that one company possesses all the expertise requested in the RFP and that teams composed of a prime contractor and subcontractors are best positioned to respond to these requirements, can you confirm that the experience of subcontractors will be considered in the evaluation process?

**Answer 2:**

When the text refers to the Bidder's experience (Point Rated Technical Criteria from Sections 2.1), Section 1.1, Part 4, of the Request for proposals applies. The experience described in the bid must be the experience of the Bidder itself.

When the text refers to the the experience of proposed resources (Point Rated Technical Criteria from Sections 2.2 and 2.3), it is implied that the experience of the resource will be considered even if the resource works for a subcontractor.
