This solicitation amendment 003 is being issued to address questions and to revise the solicitation.

### Questions and Answers:

Question 1: In Part 5 - 2.1 Federal Contractors Program - Certification, the value stipulated is "\$200,000", does this value include or not include taxes?

Answer 1: Includes all applicable taxes.

Question 2: With regards to the values under "Inputs", it states Flow Input @ 0-10VDC. Typically a controller will give variable voltage outputs via dry contacts, to a device such as a variable frequency drive (VFD), that will in turn alter the speed so as to maintain the desired constant face velocity. By design, controllers do not accept variable input voltages as part of their function. We are wondering if this spec was written in error? No Otherwise, please provide clarification as to what the type of input voltage and where it is being sent from.

Answer 2: The supply (input) voltage to the Controller shall be a constant 24 VAC. The output voltage from the controller shall be 0-10 VDC.

#### 2.1 Federal Contractors Program - Certification

**2.1 Federal Contractors Program - \$200,000 or more**

1. The Federal Contractors Program (FCP) requires that some suppliers, including a supplier who is a member of a joint venture, bidding for federal government contracts, valued at \$200,000 or more (including all applicable taxes), make a formal commitment to implement employment equity. This is a condition precedent to contract award. If the Bidder, or, if the Bidder is a joint venture and if any member of the joint venture, is subject to the FCP, evidence of its commitment must be provided before the award of the Contract.

Suppliers who have been declared ineligible contractors by Human Resources and Skills Development Canada (HRSDC) are no longer eligible to receive government contracts over the threshold for solicitation of bids as set out in the Government Contracts Regulations. Suppliers may be declared ineligible contractors either as a result of a finding of non-compliance by HRSDC, or following their voluntary withdrawal from the FCP for a reason other than the reduction of their workforce to less than 100 employees.
