AMENDMENT NO. 001

This amendment is raised to answer Bidders' questions.

QUESTIONS AND ANSWERS:

- Q1. P.9 Project Manager level 2 and P.9 Project Manager level 3 mandatory M4 for both state the following:

M4 The resource must have a minimum of 5 years' experience within the last ten years from date of bid closing with MS Access including experience with entity relationships, normalization, SQL queries, reports, Visual Basic modules and procedures and multi-user security using workgroups.

Would the Crown please clarify that the above requirement is for a project manager not a database administrator/analyst. The requirements of M4 indicates the Crown requires a database administrator or a database analyst not a project manager for doing the work. Conversely, we would request that M4 be removed from this solicitation as it does not fit normal taskings for Project Management.

- A1. The primary function of both positions is project management, but an essential although minor function of both is use and maintenance of several existing MS Access databases. Database management is not a significant enough portion of the work to justify a dedicated database manager, but it is nevertheless an essential function. M4 can therefore not be removed from this solicitation.
