Question 226

Reference: Part 7 - Resulting Contract Clauses - Article 7.5 - Security Requirement (Canadian Contractor) and Bid Solicitation Amendment # 007, Question and Answer # 164

Question: Is there a timeline in which the Bidder must have obtained the required Facility Security Clearance?

Answer: If a Bidder does not already have the required clearance, the Bidder should validate in their bid response that the Bidder has initiated the clearance process. If the validation is not part of the bid response, the Bidder must provide the required documentation within two days of a request from the Contracting Authority. Canada reserves the right to declare a bidder non-responsive if the bidder does not meet the security requirement within 120 days from bid closing date or if the bidder is refusing to participate in the clearance process.
