Q.10 Annex A-1 5.1.1.1.3 Please advise whether it's acceptable to use the lowest grade of fabric that meets or exceeds the performance requirements, putting all manufacturers on a more even playing field. Please note that lower grade fabrics are generally more popular, offer a wider color selection, and therefore are usually available in the long-term.

A10 It is not acceptable to use the lowest grade of fabric. The Bidder must meet Item 5.1.1.1.3 as specified.

Q.11 Annex A-1 5.2.3.1.4, Seat #3. Can have the option to swivel. Swivel return to 0 degrees. Our swivel returns to 0 degrees, but not automatically, please confirm this is acceptable.

A11. The Bidder must meet Item 5.2.3.1.4 as specified.

Q.12 Annex A-1 5.2.1.2., 5.2.1.3.1, 5.2.2.2.1, 5.2.2.3.1, 5.2.3.2.1, 5.2.4.2.1, 5.2.5.2.1, 5.2.6.2.1, 5.2.10.2.1, 5.2.11.2.1, 5.2.12.2.1 state "fabric to meet LEED requirements". Please confirm what the LEED requirements are or are we just to comply with Annex A-2?

Q.13 Annex A-1 5.2.4.3.1 & 5.2.5.3.1. Our chair is 35"h, will this be acceptable?

A13. The chair must meet the height dimensions are stated in Items 5.2.4.3.1 & 5.2.5.3.1.

Q.14 Part 6. B #6 States all deliveries must be after hours and installation during regular business hours. Many of these items in the bid are simply unloaded and placed in site (installed). Can deliveries and installation both take place at the same time? or, will a secure loading dock be available to store the product so that installation can take place during regular business hours?
