This solicitation amendment no.#2 is being raised to answer questions that were received.

Q1) Please provide the number of cameras onsite?

A. There are 57 cameras

Q2) Please provide the number of access control doors onsite (or approximation)

A. There are 14 man doors and 13 gates.

Q3) Please provide details re B. Scope of Work Section 4. System Hardware, 'Replacement of system as required within 48 hours to include the following'. Some questions I have:

The product listed may or may not be available within 48 hour delivery, is the contractor required to carry this equipment as spare? If so, will the Contractor quote the replacement or equivalent in addition to contract, to have available as spare? Is the intent to have a spare "system" on stand by in the event of failure, to be swapped out with 48 hours? Does DND have this equipment on hand as a spare already?

A. If the Contractor is onsite repairing a system and for whatever reason can't repair it, a back-up system would have to be used while the original system is being repaired. If the exact equipment isn't available for use, compatible or equivalent equipment can be used until the repair is done. The Contractor would then take back the back-up equipment when the original system is repaired. There currently is no spare equipment on hand at DND.

As well, the current alarm systems onsite are analog systems. Eventually they may be upgraded to digital alarm systems however DND doesn't have an exact date of when this could happen.

If your proposal has already been submitted, you may wish to revise it. Revisions to your proposal must be submitted in a sealed envelope with the contents clearly identified on the outside of the envelope. Any revisions to your proposal must be received by the Bid Receiving Unit on or before the time and date stated on page 1 of this document. Any revisions to your proposal received after the closing date and time will be considered late and will be returned unopened.
