2. ALL INTERIOR PARTITIONS ARE TO EXTEND UNLESS NOTED OTHERWISE. BRACE AS REQUIRED.
3. PARTITIONS WHICH ARE FIRE SEPARATIONS SHALL EXTEND TO UNDERSIDE OF STRUCTURE OR 100mm ABOVE FIRE RATED SMOKE TIGHT JOINT AT TERMINATION. PROVIDE DEFLECTION JOINT.
4. AT ALL FIRE SEPARATIONS ANY PENETRATIONS OR OPENINGS MUST BE SEALED WITH APPROVED FIRE STOPPING MATERIALS TO MAINTAIN THE INTEGRITY OF THE FIRE RATED ASSEMBLY. IS MAINTAINED.
