Questions & Answers

- Q1.** Can more than one hotel facility be used to accommodate the group?
- A1.** Yes; the hotels must be located beside one another.
- Q2.** For the location, is it anywhere in the city of London, ON with a 25km restriction?
- A2.** Yes, anywhere in the city of London Ontario. The location must be easy access for 30 coach buses for drop off and pick up.
- Q3.** Is there any meal cost restrictions? Ex. National Joint Council or other?
- A3.** No.
- Q4.** The requirement asks for gyms for the training, can ballrooms be used that have carpet floors?
- A4.** No. Only hard surface floors are acceptable for both required gymnasiums.
- Q5.** Where was this group the previous year?
- A5.** The previous competition was held at Western University.
- Q6.** What size of fridge is required for the 30' x 30' room reception area?
- A6.** Two bar fridges or one fridge suitable to store bottle water, condiments and 15 boxed lunches.

Insert:

- i. Accommodations, Meals and Facilities described herein must be located in London, Ontario from Friday May 10, 2013 to Sunday May 12, 2013.
- vii. The Contractor must provide one (1) gymnasium that is a minimum 110' x 135' with a divider wall. The gymnasium must be located a maximum of 1km from residence and be available from 6:00 am May 11, 2013 to 12:00 pm May 12, 2013

The gymnasium must have theatre style spectator seating for a minimum of 500 people.

The gymnasium must have hard surface floors.
