Question 3.1 :

Can DRDC expand on the specific areas of tool customization that they will be focusing on under this contract. Specifically, we wish to understand whether the intent with respect to customization of the tool is to focus on 1) Core customization (E.g. drivers, services and core functionality of the agents), 2) Database functionality (E.g. stored procedures, reports, imports and exports etc), or 3) Interface development or add-ons. A better understanding of the areas DRDC wishes to explore during the customization tasks will ensure that we identify the correct skill-sets in the proposed technical resources.

Answer : The customizations will focus on 1) core functionalities of the agent and 2) database functionality. We do not intend to use the 3) GUI much, since we want to integrate the cyber incident response tool to our existing framework that already has a GUI.

Question 3.2 :

Can DRDC elaborate on how they expect that the customized product at the end of the mandatory phase will be deployed throughout the Department of National Defence. Specifically is the expectation that DRDC and DND will have worked with industry to develop a tailored product that meets DND needs and is only made available to DND or that the winning bidder will be able to sell the customized solution to other customers. Is the expectation that DRDC will own the product (a custom application) outright at the source? In support of this, is it expected that DRDC/DND will require source code escrow or access to the code base not being customized during the contract? What usage rights will the bidder retain to the custom version or the source code?

Answer : At the end of the contract, if the customized product is of interest to DND, DND will be able to purchase licences at the price specified in the contract.
