2.1 Electronic Business Information Requirements

2.1.1 *Instructions*

Context

- 2.1.1.1 Appendix “F”, Electronic Business Information Requirements provides a description and mapping of electronic data to be provided by the contractor for Canada’s data repository.
- 2.1.1.2 The Contractor is to submit data to Canada in a pre-determined format herein after referred to as “transactions”
- 2.1.1.3 Transactions are to be submitted on a scheduled basis as outlined in this Statement of Work or as agreed to between the Contractor and the Technical Authority.
- 2.1.1.4 Electronic data submitted in transactions by the Contractor will be used by Canada to produce business reports from its own electronic systems.

Scope of Services

- 2.1.1.5 The Contractor must submit to the Technical Authority the data related to the transactions outlined in this Statement of Work according to the technical specifications described in Annex “J” and the schedule described in Appendix “F”;
- 2.1.1.6 The Contractor must transfer electronically to the Technical Authority the information requested in this Statement of Work in the manner and format as identified or as directed by the Technical Authority.
