Title: Removal and Disposal of Garbage and Recyclable Materials, DND 4 Wing Cold Lake, Cold Lake, Alberta

This amendment #001 is raised to answer questions for solicitation W0134-12CYIT/A as follows:

Question 1: What is the distance of Primrose Lake Evaluation Range (PLER) from 4 Wing Cold Lake?

Answer 1: The distance in kilometres from 4 Wing Cold Lake to PLER is 54 kms.

Question 2: What is the name of the highway to PLER?

Answer 2: Highway 897.

Question 3: Does waste from the digester dump into bin and then get vacuumed out?

Answer 3: Yes. Suggestion was made to have bin coated.

Question 4: Can a breakdown of the front load versus roll offs be provided?

Answer 4: Yes. Roll offs comprise of about 18 trips per year of dry waste. Landfill tickets are to be included with supporting documentation for invoice and will be paid when invoice processed.

Question 5: What happens when landfill fees change?

Answer 5: Landfill charges (Year 2-4) will be reimbursed at Contractor's laid down cost, without mark-up, supported by invoices.

Question 6: Can another bidder NOT in attendance at this Mandatory Site Visit submit a bid?

Answer 6: Bidders who do not attend or send a representative will not be given an alternative appointment and their bids will be rejected as non-compliant.

Question 7: Can we supply 8-Yard bins instead of 6-yd bins as this will result in less on site requirements and savings to CFB, Government of Canada and its stakeholders?

Answer 7:
