The purpose of this amendment is to publish answers in response to questions received regarding this TBIPS SA RFP.

THE FOLLOWING CLARIFICATION FORMS PART OF THIS TBIPS SA RFP:

Question 1) With regards to the I.11 Technology Architect – Solution Architect (level 3):

· For rated requirement R-3, “The bidder’s proposed resource should demonstrate experience within the last 10 years as a Technology, Enterprise or Application Architect on projects implementing Peoplesoft and/or SAP ERP’s.” Would the crown consider revising this requirement to include “Oracle E-Business Suite”, which is similar to Peoplesoft and SAP?

Answer 1) No, the mandatory requirement at R-3 for this resource will remain as written. HRSDC is looking for a resource that has experience with one or both of the ERPs that are being implemented (i.e.: SAP/PeopleSoft). Oracle E-Business Suite experience would not provide any pertinent experience for the project.
