Amendment # 001 is raised to:**A) Clarify company questions received during the Letter of Interest (LOI).**

Question # 1: If we have multiple products to submit for active combat ID, please advise how this should be done.

Answer # 1: If the supplier is proposing multiple independent active combat identification (ID) devices they should be filling in Appendix 1 to Annex A of the Letter of Interest (LOI) for each of these devices. However, if the proposed active devices must be used together then the supplier should be filling in a single Appendix 1 to Annex A of the LOI for the devices in question (i.e. for all the dependant devices).

Question # 2: What is the method of delivery for the proposals? Do you require the bids to be submitted in hard copy or can they be sent as a PDF via e-mail?

Answer # 2: Canada's request for the delivery of response packages is as follows:

Delete: LOI Article 11 - Notes to Vendors in its entirety, and

Replace: The above-mentioned deleted text with the following:

11. Notes to Vendors

Suppliers wishing to submit a response are requested to respond in writing by the closing date on Page 1 of this notice.

If there are any discrepancies between the English and the French versions of this LOI, the English version shall take precedence.

Any questions or clarifications related to this LOI or any other related inquiries shall be directed to the PWGSC Contracting Authority identified in Section 9.

Four (4) hard copies and four (4) soft copies of the information packages are requested. The soft copies can be in either PDF or Word format and should be submitted in the form of a CD along with the hard copies to the address on the front left hand side of the cover page of the Letter of Interest (LOI).

Supplier point of contact information should be included in the package.

B) Extend the solicitation closing date to 02:00 PM EST on 13 June 2012.
