This amendment is being raised to answer questions to date and correct an administrative error in Annex F:

Q1 - Are Bidders required to have testing procedures in place for the professional services such as computer engineering similar to the testing for administrative services?

A1 - No, for the technical or professional classifications, Bidders must describe how they assessed or verified the individual's skills.

Q2 - Is the insurance letter required at the time of bid closing?

A2 - No, if the information is not provided in the offer, the Standing Offer Authority will so inform the Offeror and provide the Offeror with a time frame within which to meet the requirement. Failure to comply with the request of the Standing Offer Authority and meet the requirement within that time period will render the offer non-responsive.

Q3 - Is Errors and Omissions Insurance required?

A3 - Commercial General Liability Insurance is required. The Offeror is responsible to decide if additional insurance coverage is necessary to fulfill its obligation under the Standing Offer and to ensure compliance with any applicable law. Any additional insurance coverage will be at the Offeror's expense, and for its own benefit and protection.
