The purpose of this amendment is to make several administrative changes to Attachment 4.1 - Evaluation Criteria and to extend the closing date.

THE FOLLOWING AMENDMENTS FORM PART OF THIS TBIPS SA RFP.

Change 1) In the Attachment 4.1 - Evaluation Criteria:

Insert a new requirement, M-6 in the Mandatory Requirements

The bidder must demonstrate that the proposed resource has experience in 2 projects as an Enterprise Architect at a Government of Canada department or Central Agency on an enterprise-wide business transformation project, utilizing the Canadian Government's Strategic Reference Model. For project experience to qualify, the resource must have been on the project for a minimum duration of 6 months within the last 10 years, and the project must have a value in excess of \$10M or the project must have as its target the transformation of the business design of an organization with at least 5000 employees. The following strategic reference models will also be accepted in place of the Canadian Government's Strategic Reference Model:

- Canadian Governments Reference Model (CGRM)
- Municipal Reference Model (MRM)
- Provincial Services Reference Model (PSRM)

Change 2) In the Attachment 4.1 - Evaluation Criteria:

Change 3) In the Attachment 4.1 - Evaluation Criteria:

Delete at R-5 in the Rated Requirements and in the Scoring Scheme

The bidder must demonstrate that the proposed resource has project experience as an Enterprise Architect at a Government of Canada department or Central Agency on an enterprise-wide business transformation project, utilizing the Canadian Government's Strategic Reference Model. For project experience to qualify, the resource must have been on the project for a minimum duration of 12 months within the last 10 years, and the project must have a value in excess of \$10M or the project must have as its target the transformation of the business design of an organization with at least 5000 employees.

2 or more projects = 2 points

Insert at R-5 in the Rated Requirements and in the Scoring Scheme

The bidder's proposed resource should have valid certification in an industry recognized strategic planning methodology or framework, e.g. Association of Strategic Planning or Foresight, or project experience analyzing strategic plans and aligning and validating them to business architectures and business models within the last 10 years. For project experience to qualify, the resource must have been on the project for a minimum duration of 6 months.
