This Request For Proposal (RFP) amendment 018 is to amend the RFP, distribute responses to inquiries and other communications so far submitted to Public Works and Government Services Canada (PWGSC) Contracting Authority.

Questions and Answers:

Q124. Reference: para 3.2.3 to Volume 1, page 29 of 71.

The reference para reads "...the bid must be compatible with Microsoft Office Suite 2000 for Microsoft windows operating system." Would it be acceptable to provide the bid in Microsoft Office 2003?

A124. YES. The bids can be provided in MS office 2003. The RFP is amended accordingly.

Q125. Software Licenses

Canada has requested a device license per Volume 2, Article 26.1 (Licensed Software page 35 of 124). Per 4003, a "Device" means equipment having a physical central processor unit (CPU), mass storage and input output devices such as keyboard and monitor and includes servers, desktops, workstations, notebooks, laptops, personal digital assistants and mobile computing equipment".

For the purposes of the BMA software, please confirm that a "Device" is the ISS-ES and that Canada requires one BMA software Device License for each ISS-ES delivered.

A125. PWGSC will consider the acronym "BMA software" as in fact being "Battle Management System (BMS) software". PWGSC confirms that a "Device" is the ISS-ES and that Canada requires one BMS software Device License for each ISS-ES delivered. In fact we consider the software, like all other software to be provided, as a LRU that should be listed with its unit price in the volume 2 annex AB Financial Bid Presentation Sheet Part 2 items 10.1.1., 13.1.1., 17.1.1 and Appendix 2 items 1.1.1, also in Volume 3 Part 1 item 9.1.1.

Q126. Software Licenses

monitor and includes servers, desktops, workstations, notebooks, laptops, personal digital assistants and mobile computing equipment".

Please confirm that the BMA software Device license quantities listed in the deliverable tables of Annex CF of Volume 2 are in addition to the BMA Device License to be delivered with each ISS-ES.

A126. Yes, we confirm. For your information, the 1600 ISS-ES to be delivered (the quantities) are in the Financial Bid Presentation Sheet volume 2 annex AB item 13.1.1 and not in the volume 2 annex CF table 2.2 (168 ISS-ES + 176 ISS-ES) and table 2.3.2 (628*2 ISS-ES). Your quoted prices must be in the volume 2 annex AB and not in the annex CF. The annex CF shows how things will be delivered and where. The annex AB shows what will be delivered, the total Qty and at which price. The broke down quantities of a same object in annex CF are consolidated in annex AB.

BMS are to be delivered with each ISS-ES in the quantities specified in volume 2 annex AB Financial Bid Presentation Sheet Part 2 items 10.1.1., 13.1.1., 17.1.1 and Appendix 2 items 1.1.1, also in Volume 3 Part 1 item 9.1.1. Lets look at 13.1.1. It says that you must deliver 1600 ISS-ES and you break down the ISS-ES in LRU and the BMS is one of the LRU, you need one BMS per device therefore 1 device license per device. You create a line '13.1.1.x BMS Software', put '1600' as quantities, the quoted unit price and the extended price.

Separately, in volume 2 annex AB Financial Bid Presentation Sheet Part 2 item 13.4.3 you have the quantities for the BMS software to be installed on a CF laptop that is also a device. The quantities of 96 is equal to the QTY from annex CF (28+28+20+20).

Q127. Software Licenses

Please confirm that the SEP-S software Device Licenses are to be delivered only in the quantities listed in the deliverable tables of Annex CF of Volume 2 (for lap tops).

A127. PWGSC confirms that the SEP-S software Device Licenses are to be delivered only in the quantities listed as per Volume 2 annex AB Financial Bid Presentation Sheet Part 2 items 10.4.2. and 13.4.2.
