SC01 INSURANCE TERMS

G1001C 2008-05-12 - Insurance Requirements

The Contractor must comply with the insurance requirements specified in Contract No. EZ899-130290. The Contractor must maintain the required insurance coverage for the duration of the Contract. Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract.

The Contractor is responsible for deciding if additional insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any additional insurance coverage is at the Contractor's expense, and for its own benefit and protection.
