The purpose of this amendment is to respond to the following questions;

Q1: Can a security clearance be issued to companies that do not have offices inside Canada and to individuals who are not Canadian Citizens?

A1: Yes, please contact the Standing Offer Authority if you require security clearances. The instructions can be found on page 1 of the solicitation documents.

Q2: The solicitation lists zone 4 as covering the following areas:

Mediterranean / Red Seas, Africa and the Middle East and surrounding areas, defined as ports along the southern coastal border of Portugal, starting at Cabo de Sao Vincent, including Gibraltar, the coastal areas of the Mediterranean Sea and all adjoining bodies of water (ie, Adriatic and Black Seas); the Red Sea; coastal areas of the Gulf of Aden; Persian Gulf; Gulf of Oman; Arabian Sea and Indian Ocean to Cape Comorin, India; Sri Lanka; the coast of Africa; and, all adjacent islands such as the Azores, Madeira, Canary Islands, Cape Verde Islands, Madagascar, Seychelles, Maldives, and other islands within the surrounding areas.

The areas highlighted in yellow above are currently covered under Zone 8 of Standing Offer W0103-126509/001/VIC. Will the area currently covered in Zone 8 of the above mentioned standing offer transition to Zone 4 in the standing offer(s) resulting from this solicitation?

A2: The areas of responsibility identified in yellow above will be transitioning to an East coast responsibility. While those areas are currently identified in the Deployed Logistics Service Support Standing Offer (DLSSSO) from the West coast, they will not be covered in the West coast's new Standing Offer when tendered. While this will cause overlap until such time as the West coast has its new DLSSSO in place, East coast Ships will be using the East Coast DLSSSO and West coast Ships will be using the West coast DLSSSO for that overlap period. This overlap period will only be a short timeframe and the use of each will be communicated to HMC Ships Logistics Officers.
