1. EXTENSION

Notice is hereby given that the time for the reception of tenders previously due May 31, 2012 is hereby extended to 14:00 hours, June 5, 2012.

2. QUESTIONS AND ANSWERS

Q1

In Amendment #004, Q14, we were to be provided the required information and scope for the EMCS. Please advise the schedule for release of this information.

A1

The TAC Vista Building Automation System is at Springhill Penitentiary and has been upgraded in the last year and has the latest version of software.

The Alerton BACTalk Building Automation System is at the Atlantic Institution has been upgraded in the last year and has the latest version of software.

Q2

We refer you to Q11-A11 of Amendment #4 whereby information was to be provided for connections to the central heating system. This information still has not been provided. Are we to assume that the heating will be 1.5 metres outside of the new building footprint and the remainder of the required installation/hookup will be performed by others or as additional work to the Contract?

A2

The work is not to be done by others. The intent of the value as set by PWGSC is that mechanical design naturally works from the inside of the building to hook ups relatively 1.5m outside the building. CIVIL design then takes lead on service connections, design. The design build team is responsible for all design and all construction.

Q3

On Page 114 of 188 of the Terms of Reference, the floor to floor travel for the Elevator is set at 3700 mm. Is this the floor to floor height required and expected by the Owner for the Project?

A3

Yes. Lower floor: 3700 mm finish floor to finish floor and Upper floor: 3700 mm finish floor to underside of lowest roof structural member.

Q4

Can we use 6 high 9 Ga. X 2 chain link construction panels for the laydown areas at both institutions as well as the work site perimeter in Renous? (Is this considered minimum/medium as we are outside the perimeter wall/fence?)

A4

This can be used at Atlantic Institution, Renous.

Q5

Clarification for the temp. fence security in Springhill or Renous - See addendum #6, item 3.3.3.5 The fence is closer than 12m in some areas please clarify.

A5

Section 3.3 does not apply for the GI projects. Only 3.2 Temporary Construction fences for Medium and Maximum institutions applies. As well as the new qualities for the fences as outlined in Addendum 015.

Q6

Are we to install rough-in (conduit) only for CCTV and security systems? Card reader at the door? Are all devices, wiring and termination by owner please confirm.

A6

See Spec and Drawings for details. Conduits to be provided as part of this contract. Devices and wiring etc. are by Owner.

Q7

Given the extensions made to the RFP, the milestone dates as detailed in the RFP are not reasonable and need to be revised. Based on a tender closing date of May 31, 2012 and subsequent award in a two or three week timeframe, the January 31st Substantial Completion date is not achievable. Annex C on page 33 of 95 of the RFP states that we are to be complete in 42 weeks which will be required to execute the design and construction of these two buildings. Please advise that Annex C is correct and the Project Milestone dates are to be revised accordingly based on the contract Award Date.

A7

Project Milestones are to be revised accordingly to the 42 week completion requirements outlined.

Q8

Is a fire pump required for the sprinkler system?

A8

This would be part of the design build requirement.

Q9 In the Terms of Reference, page 65, item 4.3.16.6 indicates a Health & Safety Coordinator to be onsite for the projects. Can this individual be our Site Superintendents at each site, or is it a requirement for another individual to the H&S Coordinator? If it has to be another individual from our Superintendent, will this person be expected to be onsite full time for the duration of the project?

A9

It is not required to be separate person.
