This Amendment is raised to provide answers to questions from potential suppliers.

Question 1:

1) The solicitation closes August 30,2012. Can we get an extension to respond to this closing to September 13th?

Question 2:

2)Re: 2. Part 5-Certifications 1.1 It is requested that Suppliers submit a complete list of all individuals who are currently directors AND completed, signed Consent to Criminal Record Verification forms. Our corporation is a NYSE listed company with an international Board of Directors.Due to the logistics involved in getting these forms completed and signed,can this requirement be extended beyond the closing date with the condition that all forms will follow as soon as possible?

Answer 2:

As per Part 5 - Certifications; clause 1 - Code of Conduct Certifications - Consent to a Criminal Record Verification, Suppliers must submit the list of individuals who are currently directors to the Supplier and a completed and signed Consent to a Criminal Record Verification form for each individual with their arrangement, by the RFSA closing date.

Suppliers may submit forms that have been completed and signed then scanned.

For information purposes, as per Part 6 - Supply Arrangement and Resulting Contract Clauses; Part A - Supply Arrangement; Clause 7 - On-going Opportunity for Qualification, a permanent Notice will be posted on the Government Electronic Tendering Service (GETS) to allow new suppliers to become qualified.

Question 3:

3) Given that we only received this on August 16 and given the complexity of this requirement, may we please ask for a two week extension to the closing date of this RFSO?

Answer 3:

Question 4:

4) On Amendment #2 – Question 4 – Canada has specified the following:

“A bidder is able to submit the necessary requirements under one technical proposal but must provide a separate project to be evaluated for each category in which it wants to be considered.

For example, if a bidder would like to qualify for Stream 1- Category 2: Real Property Management and Stream 2 – Category 1: Insurance and Risk Consulting Services, a project demonstrating Real Property Management experience and a project demonstrating Insurance and Risk Consulting experience (containing all information as outlined in MT1) must be submitted.”

We interpret this to mean that one technical proposal is sufficient for both Stream 1 and Stream 2 categories as long as it includes a separate relevant project for each category under consideration. However, page 9 of the RFP under Part 3 – Arrangement Preparation Instructions reads:

“The Supplier can submit more than one stream of work specified in the Statement of Work but must submit one technical arrangement for each specified stream. Canada requests that the Supplier clearly identifies in the first pages of its technical arrangement for which stream of work it is submitting.

We interpret this to mean that one technical arrangement is required for work submitted under Stream 1 Categories and one technical arrangement is required for work submitted under Stream 2 Categories.

Under the assumption that the bidder will be submitting work for categories under Stream 1 and Stream 2 please clarify that two separate technical arrangement are required.

Answer 4:

In order to provide better clarity, the following updates are applicable:

Under Part 3 – Arrangement Preparation Instructions:

DELETE:

“The Supplier can submit more than one stream of work specified in the Statement of Work but must submit one technical arrangement for each specified stream. Canada requests that the Supplier clearly identifies in the first pages of its technical arrangement for which stream of work it is submitting.

INSERT:

The Supplier can submit more than one stream of work specified in the Statement of Work but must submit one project per category to be evaluated within their technical arrangement. Canada requests that the Supplier clearly identifies in the first pages of its technical arrangement for which categories of work it is submitting.

Question 5:

5) If we do not currently have someone who has the required security status, can we respond that we will secure this, if successful?

Answer 5:

In order to initiate the process to obtain the required security requirements, the Supplier must contact the Industrial Security Program (ISP) at Industrial Security Services through the following link:

If the Supplier wishes to proceed with the process, a Request for Private Sector Organization Screening

form will be forwarded to the Contracting Authority for completion and sponsorship.

Question 6:

6) [Page 14] Part 5 – Certifications – Code of Conduct Certifications – Consent to Criminal Record Verification requires suppliers to submit a properly completed and signed form Consent to Criminal Record Verification for each named director of the supplier. Our directors have all previously completed Criminal Record Checks through PWGSC and hold current valid Government of Canada Security Clearances at the level of Reliability Status or higher. Does providing our Directors' valid security clearance information within the Proposal meet the requirement? Or is it required to re-submit these forms with the Proposal?

Answer 6:

The forms must be submitted with the proposal as per Part 5 – Certifications; clause 1 - Code of Conduct Certifications - Consent to a Criminal Record Verification.

Question 7:

7) We respectfully request an extension to the closing date of this RFP of September 13, 2012.
