This amendment is raised to change the closing date of the solicitation, to address questions raised during the solicitation period and to make changes to Annex A-1.

Questions and Answers

Q1. Annex A1 6.1 requests "removable connection to floor monuments" be provided. As these are separately specified items and only one is required to power multiple tables how many are needed for this requirement?

A1. The scope of work for the RMSO will be performed on an "as and when requested basis", therefore, quantities cannot be provided.

Q2. Section 6.6 requests wood veneer or metal modesties . Our standard is fabric wrapped. Is this acceptable?

A2. No.

Q3. Section 7.1 requests laminate or metal modesties. Our standard is fabric wrapped. Is this acceptable?

A3. No.

Q4. Please confirm that PWGSC desires that the tops for T1 is actually veneer with hardwood edging versus wood grained laminate. We ask as these tables are flip top units designed to be Nested and as such the tops will be subjected to a significant amount of contact with other tables etc. Wood veneer is not a durable material for this application.

A4. Refer to Section 2 of the amendment for more information.

Q5. Please confirm which of casters or glides is desired for the pricing of Table T1.

A5. Casters are required for the pricing. Glides are deleted.

Q6. Please confirm which of casters or glides is desired for the pricing of Table T2.

A6. Casters are required for the pricing. Glides are deleted.

Q7. Part 6, A, 2.2, v Standing Offer Reporting; Would you please explain what is meant by the terminology 'active status' with respects to a call-up.

A7. Please delete article v. of this section.

Q8. If products need not be from the same manufacturer as stated in 1.3 of Annex A-1 why is there a restriction to having only one resultant RMSO as noted in Part1 , para 2.1? Would not the Crown result in savings if awards were made to the bidders with the best price for each item listed?

A8. The management of several Standing Offers for all the items listed is not in the best interest of the Crown. The pricing will be based on lowest aggregate of all items listed and should result in savings to the Crown.

At Annex A-1, section 5.11:

Delete in it's entirety.

5.11 Finishes - Horizontal surfaces must be constructed of wood veneer, complete with solid wood edge to match the wood veneer or PVC edge and plastic laminate as specified. Supports must be constructed of metal with polished aluminum (or similar finish). Modesty panel must be constructed of wood veneer or plastic laminate or metal I with polished aluminum (or similar finish) as specified. Polished aluminum (or similar finish) table top monuments.

Insert:

5.11 Finishes - Horizontal surfaces must be constructed of wood veneer, complete with solid wood edge to match the wood veneer and high-pressure laminate with PVC edge, as specified. Supports must be constructed of metal with polished aluminum (or similar finish). Modesty panel must be constructed of wood veneer, high-pressure laminate or metal with polished aluminum (or similar finish), as specified. Polished aluminum (or similar finish) table top monuments.

At Annex A-1, section 5.6

Delete:

Must have levelling mechanism with vertical adjustment of at least 25mm (1").

At Annex A-1, section 6.6:

Delete in it's entirety.

6.6 Finishes - Veneer species & finish colour to be determined by designer from manufacturer's full range. Modesty panel must be wood veneer or metal.

Insert:

6.6 Finishes - High-pressure laminate and wood veneer. Species and colour to be determined by designer from manufacturer's full range. Modesty panel must be wood veneer, high-pressure laminate or metal.

At Annex A-1, section 7.1:

Delete in it's entirety.

7.1 Finishes - Plastic Laminate - colour to be determined by designer from manufacturer's full range. Modesty panel must be plastic laminate or metal.

Insert:

7.1 Finishes - High-pressure laminate - colour to be determined by designer from manufacturer's full range. Modesty panel must be high-pressure laminate or metal.

At Annex A-1, section 8.1:

Delete in it's entirety.

8.1 Vertical surfaces and supports must meet the performance requirements for finishes as stated in CAN/CGSB-44.227 – Table 1.

Insert:

8.1 Horizontal work surfaces and supports must meet the performance requirements for finishes as stated in CAN/CGSB-44.227 – Table 1.

At Annex A-1. Section 9.0:

Insert:

9.3 Four metal finishes must be available.

At Annex A-1. section 9.1:

Delete in it's entirety.

9.1 Four plastic laminate sample cards must be available, one of the cards must be a white finish and two of the cards must be wood look.

Insert:

9.1 Four high-pressure laminate sample cards must be available, one of the cards must be a white finish and two of the cards must be wood look.
