- Q.1.** Optional Goods: for how many years must we guarantee pricing for the optional goods?

- A.3.** It is not intended to provide protection against fluctuations in exchange rates and C3011T item has been added to the Solicitation Amendment 001.

- A.4.** No, these goods are not controlled goods.
