This amendment is issued to respond to enquiries submitted on the Request for Information (RFI) for the Inmate Telephone System.

Enquiry 1

Are there restrictions that prohibit administration access to the Call Control Service via secure web interface from Ministry computer terminals in place of a standalone network of computer terminals.

Response 1

Correctional Service Canada (CSC) 's requirement would be for a standalone network of computer terminals.

Enquiry 2

Annex A, Section 2.6 - Can you provide an example of a future collateral service?

Response 2

Future collateral services may be include services such as Inmate Canteen and libraries.

Enquiry 3

Can you be more specific about the number of enclosures required and any restrictions associated with the type of furniture? For example, should the enclosures be all steel or aluminum?

Response 3

The Inmate Telephone enclosures must be of a robust construction, and therefore must be made of an extremely durable material such as steel. Other materials, which are equally strong and durable as steel (such as some plastics), would be acceptable provided that the material is such that it would be impossible for an inmate to break off or shatter the material in a manner that would produce debris that could be used as or worked into a weapon.

The majority of enclosures are currently owned by CSC and it is expected that any additional enclosures that may be required would be no more than 400.

Enquiry 4

Are the Smart Cards that are currently used commercially available and are they customized specific to the inmate at all? For example, do you put the inmates' picture on the card?

Response 4

They are a standard commercial cards and are not customized.

Enquiry 5

Can you elaborate on the financial transactions associated with inmates? For example:

- a. How do Friends/Family deposit money into an inmate's trust account? What payment methods can they use?
- b. Is the smart Card used for any other purpose in the jail such as Canteen?
- c. Are the inmates funds segregated into a separate phone account or is everything managed out of the Trust Account?

Response 5

- a. This is handled by the individual institution on behalf of inmates. There would be no involvement in this process by the contractor. As such, the requested information is not relevant to the Inmate Telephone System RFI..
- b. Currently, the smart card is used exclusively with respect to the Inmate Telephone System.
- c. This process is internal to CSC.

Enquiry 6

It appears that the Ministry utilizes a dual authentication consisting of a Smart Card and a PIN. Does the Ministry also use or plan to use a biometric to further identify the caller?

Response 6

There is no plan, at this time, to implement this additional authentication nationwide as part of any future services contract.

Enquiry 7

Do you currently have any integration between your existing Offender Management System and the Inmate Telephone System?

Response 7

There is no integration currently between CSC's Offender Management System and the Inmate Telephone System.

Enquiry 8

Are the current cut-off switches owned by the Ministry or will we need to provide new cut-off switches?

Response 8

The cut-off switches are physical switches installed at the institutions and are the property of CSC. The successful contractor of the proposed Inmate Telephone System would be responsible for connecting their system to these switches and ensuring their proper operation.

Enquiry 9

Can you elaborate on the functionality and integration requirements of your current call recording technology?

Response 9

The current system consists of two parts:

Part 1: audio and on/off hook by bridging across the phone line

Part 2: the service provider sends data packets to the recorder via DSL link with origin phone number, PIN number and destination phone number.

The data and audio are correlated using the Origin Number as the common item.

An algorithm would then define if the call should be recorded or suppressed based on warrant data and the suppression list

The recorder is currently being upgraded to a newer offering from Eventide.

Enquiry 10

Can you provide a list of the current rates charged for debit and collect calling?

Response 10

The rates are confidential.

Enquiry 11

Does the contract with your current supplier stipulate how quickly they must remove their phones? For example, could you require them to remove 20 phones per day during a transition?

Response 11

The information is confidential.

Enquiry 12

Would it be possible to tour one of your facilities to get a better understanding of the day to day operation of the phone system and how it integrates with your current systems? This would allow us to better understand and highlight for CSC the improved efficiencies that can be offered.

Response 12

There are no site visitations with this RFI.

Enquiry 13

Can you provide a full list of the locations and addresses for the facilities that require either inmate phone service and/or access to the ITS platform? We need this information so that we can work on our solution prior to the RFP release.

Response 13

A list of institution locations/addresses is attached. Note that the proposed Inmate Telephone System would have to be fully functional at each of the correctional institutions and headquarters locations listed in Appendix B of Annex A of the RFI. Appendix B of Annex A of the RFI provides the number of inmate telephone sets and workstations that would be required at each institution and headquarters locations.

As noted in Section 2 of the RFI , potential suppliers of any goods or services described in the RFI should not reserve stock or facilities, nor allocate resources, as a result of any information contained in this RFI. The procurement of any of the goods and services described in this RFI may not necessarily follow the RFI. The RFI is simply intended to solicit feedback from industry with respect to the matters described in the RFI.
