Addendum No. 3

QUESTIONS AND ANSWERS

Q1: Are we responsible to pay for Commissioners during this project.

A1: Contractor is responsible for Commissioners fees. For access to the 3rd floor, owner will provide the commissionaire as there are specific security requirements involved.

Q2: IT has been noted that Buss duct was previously purchased by owner and can you clarify what hardware and connector kits is required to be purchased by contractor

A2: Owner provides the bus duct system, included the electrical connectors. The Contractor will be responsible to provide support channels, hanger rods, fasteners and any other hardware required in accordance with the contract specifications.

Q3: Are the new batteries supplied by owner

A3: Yes, the new batteries are supplied by the owner

Q4: During shut down are maintenance electrician present to verify proper breakers are shut down

A4: Yes. The Contractor will be responsible for the fees associated with having SNC Lavalin maintenance staff present, as required.

Q5: Who is responsible for removing and reinstalling the suspended ceiling for the new bus duct as per detail Partial level 4, floor 3 plan dwg. E101.

A5: The contractor is responsible for the suspended ceiling modification. Please refer to section 01 73 00 part 1.5.9(.11)

Q6: The scope work in the data center 3rd floor can be done during normal working hours?

A6: It would be preferred that the work be completed during the day time on week days with the exception of the connection of bus duct #2 to its new extension. This should be completed outside working hours as it will require a power shutdown and potential loss of service.
