Addendum No. 1

The following changes in the tender documents are effective immediately. This addendum will form part of the Contract Documents.

1. The section 10 73 00 it asks for protective cover to have a full time on staff licensed engineer and for the manufacturers to be approved a minimum of ten days before the bid. This spec for a 15' x 8' shelter. Can the person doing the structural steel build and install it as long as they provide engineered drawings?

The building manufacture does not need to be approved before bid. Yes, the person doing the structural steel can build and install the shelter as long as they provide engineered drawings for approval before construction of the shelter.

2. Can the 12" supply header have grooved tees rather than welded tees so we can fabricate it on site making it cheaper?

We assume you are talking about the 12" supply header underneath the new aeration column. Grooved tees are acceptable alternatives to welded tees, but the piping will have to be supported from the structural framing above. A piping support plan will have to be supplied the Departmental Representative for approval prior to installation of the supply header.

3. Can the piping that goes to and from the turbine be grooved?

The piping going to and from the turbine shall be flanged. This is to facilitate ease of assembly/disassembly of the system for inspection and maintenance.

4. Much of the piping has too many fittings to coat the inside of the pipe. Can it be changed to stainless to eliminate the coating or can additional flanges be added to achieve the inside coating?

The piping running to the turbine can be either 304 stainless steel or epoxy coated mild steel.

5. How long is the aeration tower able to be shut down for to complete this work? In the past there is a really long lead time on receiving the equipment. Sixteen weeks seems really tight. Is there any room to extended the construction time?

This is an operating facility and the aeration tower will be in operation during construction and cannot be shutdown. It is the contractor's responsibility to isolate their work in the aeration tower without effecting operations or allowing contaminants to enter the rearing water supply.

The construction time will be extended to twenty-four (24) weeks. However, all work over the aeration reservoir must be completed in the original 16 week time frame.

6. It states multiple time in the specs that the Bidder will not be allowed to change the project team members or subcontractors after award of contract without specific prior approval by the Departmental Representative. Is the Contractor going to have to list their team after the tender close and prior to award?

The successful bidder shall supply a list of subcontractors after contract award, but prior to the start of construction.
