2 **QUESTION AND ANSWER**

Q1: What if a company does not have a Board of Directors or even a Director but is just an owner/operator - is it still a mandatory requirement to fill out the form and if they do not fill out the form, can they be declared non-responsive as our instructions specify Board of Directors or Directors.

A1: Some bidders will not have a Board of Directors, as they are sole proprietors and/or they are partnerships and/or limited liability partnerships. For a sole proprietor, the proprietor must identify himself or herself as a director and complete and sign the consent form. For a partnership or a limited liability partnership, all partners must be identified as directors and each must complete and sign the consent form.

All other terms and conditions remain the same.
