Requirement: Storage Cabinets.

This solicitation is hereby amended to reflect a question from a bidder and the answer from the consignee.

Bidder's question:

"Annex "A" states that the storage capacity of the unit must be 73 cu. ft. (+/- 2) and that the outside dimensions must be 105 x 28 x 42". These dimensions calculate to exactly 73 cu. ft and therefore, leave no cu. ft. available for slides, drawer spacing, etc.

Storage capacity is usually defined as the total space available inside the drawers. In this case, we assume that 73 cu. ft. refers to the total space inside the unit and that the actual storage capacity inside the drawers is something less. Please confirm this point."

Consignee's answer:

That is true. the 73 cubic ft refers to the total inside space. The drawers and slides are part of the inside storage space and the capacity of the drawers will be less.
