Question: Where would SIT at origin fit in regards to the shipments sitting on your dock while we wait for the appropriate paperwork to export the shipment as it can sometime take weeks for approval? Or will it be quoted on a case by case scenario?

Answer: "Storage (LTS and SIT), for periods for less than a full month must be prorated on a daily basis, this includes bonded storage and PMVs. Rates are to be for the life of the LTS lot. Bonded storage is be charged at the same rate as LTS." 15 days of free SIT after which time the LTS rates apply for the ongoing storage of shipments which are stored while awaiting onward transit to destination.

Question: In the case that there is a car plus personal effects to ship, will the GTT only start once paperwork has been received for both portions? Or are we to ship separately?

Answer: The expectation is that household effects and the vehicle are shipped at the same time, unless there are extenuating circumstances which will cause delays in the shipment. In these circumstances, a decision will be made on a case by case basis to ship separately. The GTT commences once the effects are packed unless the offeror advises the department of a situation.
