**QUESTION 1:**

*"We would like to request a Word version of the RFP. (PWGSC- Professional Services-EP304-131244/A- Client Reference: 20131244)"*

**ANSWER 1:**

The RFP is not available in a Word version.

**QUESTION 2:**

*"Is there currently or has there been within the past 12 months a contractor or contractors, delivering the services similar to or identical to those services being solicited in this RFP? If so, who are the incumbent contractor(s), what has been the duration of the contract or contracts and total value for the services provided to date? Also, has this firm been invited to bid on this solicitation?"*

**ANSWER 2:**

There is currently an incumbent. The Contractor is I4C Information Technology Consulting Inc., who has been performing these services for 18 months at a contract value of approximately \$1,097,460.00. As per the NPP, firms were not directly invited to bid on this solicitation. This requirement is open only to those Supply Arrangement Holders who qualified under Tier "2" (above \$2M) stream for Technology Services and who qualified under the categories for: Web Architect (level 3), Web Developer (level 2), Programmer / Analyst (level 2).

**QUESTION 4:**

*“For the Web Architect, Level 3 and the Programmer Analyst, Level 2, the mandatory criteria require experience with ColdFusion development. In the rated criteria for both of these categories, points are awarded for experience with .NET. ColdFusion and .NET are very different technologies and would not be used together, so a resource who develops in ColdFusion would not necessarily have .NET experience. We are therefore requesting that R3 (for the Web Architect) and R1 for the Programmer/Analyst be removed.”*

**ANSWER 4:**

R3 for the Web Architect and R1 for the Programmer/Analyst will not be removed.
