Questions and Answers:

Question no. 1:

Regarding Part 4 article 3 ("Product Dating"), is that to the best of the contractor's knowledge and does it fall within the 18 month shelf life guarantee on delivery as mentioned in Annex A Article 1.5 ("Product Dating")? Further to this, Article 1.8 & 1.9 refer to inspection of the stockpile: could you please clarify how this process would work based on Article 1.9's implications for the contractor?

Answer no. 1:

Bidder must submit the best expiry date of product on hand at time of solicitation. Emergency Response can inspect the stockpile at the contractor's facilities or distribution centre at anytime during normal business hours to ensure condition of product and satisfactory product dating.

Question no. 2:

As the contract has a firm end date of March 31, 2018, can solicitors expect the ordering of product by PWGSC to be consistent and spread out throughout the term or is the ordering pattern entirely at the discretion of PWGSC?

Answer no. 2:

As this will be for emergency use, the ordering is unpredictable and therefore the ordering pattern is at the discretion of the Office of Emergency Response.

Question no. 3:

In the reference to the idea of "Stockpiling", would be it correct to assuming that a guarantee of product would act the same as a stockpile? What I'm having trouble making sense of is the idea that the stockpile acts as a guarantee of supply, but since ordering is presumably at PWGSC's discretion with no guaranteed pattern, it would be hard and costly to guarantee freshness of a rotating stockpile. If you could please clarify this point.

Answer no. 3:**At Annex "A" - Requirement:****delete:****1.5 Product Dating**

The product must be rotated to ensure freshness of stock. Product must have a shelf life of no less than 18 months remaining on the date of delivery during the contract period, unless prior authorization is obtained from the Office of Emergency Response. For all orders the Contractor will contact the Office of Emergency Response at time of shipping to specify the minimum shelf life available. Failure to contact the Office of Emergency Response may result in the return of the shipment, at the Contractor's cost, where product has a shelf life of less than 18 months.

At Annex A, 2.1:**Insert:**

In the event of an emergency shipment, a shelf life of six months must remain on the product unless prior authorization is obtained by the Office of Emergency Response Services.

At the completion of contract, the contractor must deliver, at Canada's cost, the entire quantity held to a destination within Canada specified by the Office of Emergency Response Services with no less than 18 months of its shelf life remaining. If the expiry dating is below 18 months, prior authorization must be obtained by the Office of Emergency Response Services. The contractor must deliver this product using good manufacturing practices and ensure shipment is carried within temperature range for the product using a temperature monitoring device.

Question no. 4:

Clause 5.2. - Where would the various Canadian destinations be located?

Answer no. 4:

During emergency use, the product could be delivered to anywhere in Canada. Upon completion of contract, the product is to be returned to our central warehouse in Ottawa.

Question no. 5:

As Rocuronium is not a vaccine, does the clause #6 apply?

Answer no. 5:

Delete the word "vaccine" throughout this clause and insert the word "product"

All other terms and conditions remain unchanged.
