## **SECTION A - QUESTIONS AND ANSWERS**

### **Question 59**

#### **References:**

Learning Services Financial Offer Template; ANNEX A Requirements for Services Page 90 to 119.

Essentially all Streams require that the Offeror provide documentation for Minimum Mandatory Qualifications of personnel for three levels of competency: Senior, Intermediate and Junior. Pricing is also based on these qualification competency/qualification levels. Assuming that all the personnel to be submitted for a Stream meets the Senior Mandatory Qualifications, does the Offeror need to provide documentation for the Intermediate and Junior levels as well? If so, how can the Offeror do this if s/he has no such personnel?

### **Answer 59**

The Occupational Minimum Mandatory Qualifications listed in Annex A - Requirements, are the minimum consultant category qualifications for any resulting call-up or contract.

The actual Technical Evaluation for the Standing Offer (Attachment B) and for the Supply Arrangement (Attachment C) do not require the experience to be at the Senior level.

If an Offeror / Supplier does not have the required personnel available as stipulated within an Availability Confirmation Form (Standing Offer) or within a Bid Solicitation (Supply Arrangement), the Offeror / Supplier would then have to pass on that particular requirement.

### **Question 60**

COMPONENT II - Standing Offer, 7.c page 61 Right of First Refusal; Learning Services Financial Offer Template; ANNEX A Requirements for Services, pages 90 to 119; ANNEX E Basis for Payment, page 128 to 130; PART 5, Attachment D Standing Offer Financial Evaluation.

It is clear that the solicitation requires that the Offerors provide pricing for all categories of expertise (Senior, Intermediate and Junior) for the Streams and Regions they are interested in bidding for. This is not seen as a problem. However, Page 61, 7.c provides a sample calculation for Right of First Refusal. This example implies that the Identified User plans to request work done by specific Categories of Personnel, based on the pricing provided. However, the Offeror, while having submitted a bid with pricing for all categories may only have personnel in the Senior category. Does this sample calculation imply that the Offeror will receive payment based on the Categories of Personnel the Identified User prefers/plans to use or that payment will be based on the Categories of Personnel actually used or available?

---

**Answer 60**

The Offeror will be paid the firm all-inclusive per diem rate based on the Consultant Category specified in the Availability Confirmation Form by the Identified User. Therefore, if an Identified User requested a consultant category at the Intermediate level, and the Offeror provided a resource with Senior level qualifications; the Offeror would be paid at the Intermediate level.

Table of Contents (pages 2-4);

The Table of Content indicates Part 1 to 6B clearly for Components I and II. Component III does not refer to Part 7A, 7B or 7C, but just to the numbers. Can we safely assume that the word PART just dropped off inadvertently?

**Answer 61**

Pages 56 and 69, Component II

Start with Component II on page 56, the numbering system breaks down, making things confusing. Can we safely assume that on page 56, A should read PART 6A, and on page 69, B should read PART 6B?

Can we safely assume that PART 6 on page 78 should read COMPONENT III? Further, can we safely assume that A on page 78 should read PART 7A, that B on page 86 should read PART 7B and that C on page 89 should read PART 7C?

Should the title BID SOLICITATION read MODEL BID SOLICITATION instead?

No, the title is correct. This section describes various elements related to the Bid Solicitation process.

**Question 65**

Page 84, section 13

The Table of Contents on page 4 shows that item 13 under COMPONENT III, 7A deals with Joint Venture. This is not the subject or title shown on page 84. What are the clauses dealing with Joint Venture under this section?

**Answer 65**

The table of contents listed on p.4 for Component III was not updated based on the final clauses within Component III. The table of contents will be updated for any Supply Arrangements that are issued as a result of this solicitation.

Page 84 and 85, Sections 14 and 15; Table of Contents

The Table of Contents lists sections 14 to 19 with a variety of subject. Page 84 and 85 only have 2 sections, 14 and 15 apparently equivalent to Table of Contents items 14 and 19 respectively. Can you provide the missing sections. dealing with "Delivery Requirements Outside a CLCSA", "Controlled Goods" and "Publication of Supply Arrangement Information"?

Section 3.8.1.4 OCCUPATIONAL MINIMUM MANDATORY QUALIFICATIONS (page 115)

Mandatory Criteria M.1 under Senior Instructor states: "must have a minimum of 120 training days within the last 3 years in Instructing in the identified subject area". The first interpretation is that the candidate Instructor must have RECEIVED at least 120 days of training on how to instruct in the subject area. Or said another way, does this mean 120 days of Professional Development. Another possible interpretation is that the Instructor needs to have delivered to clients at least 120 days of Instruction in the subject area. Which interpretation is the correct one? (If the first is correct, I do not know how many professional Instructors manage to do an average of 40 Professional Development days in their specialty each year! Even teachers can't manage that.)

ANNEX A to COMPONENT II and III (page 90-115)

Section 3.0 details the Requirements for each Stream in turn. For each Stream, a subsection provides details on the OCCUPATIONAL MINIMUM MANDATORY QUALIFICATIONS. What detail of information and documentation of these Qualifications does the Bidder/Offeror need to submit with the bid? Is this part of the bid's Technical Evaluation section? Is this information and documentation required for each individual within the Bidder's organization who would be supplying Canada?

**Answer 73**

This information is not required as part of your bid in response to this bid solicitation. This information will only be required in response to an Availability Confirmation Form (Standing Offer) or in response to a specific bid solicitation under the Supply Arrangement.

**Question 74****References:**

PART 4. Section 4.b (page16) Attachment B, M.2(h) (page 20 and pages 27-28)

Section 4.b (page 16) for Financial Viability specifies that for Joint Ventures, "financial information required by the Offer/Arrangement Authority must be provided by each member of the joint venture". Attachment B (p. 20) qualifies that in case of a joint venture, that at least one member of the joint venture must meet the requirement of M.1. However, there is no similar qualifier for M.2(h). Based on PART 4, 4.b, the logical interpretation is that each member of the joint venture "must provide the information" which would need to substantiate billings of \$150,000 over 5 years. Could the requirement be modified in the case of a joint venture, so that the sum of the total billings by the members of the joint venture be at least the required minimum of \$150,000 over 5 years?, rather than applying the requirement to each individual member of the joint venture?

**Answer 74**

Section 4.b on page 16 deals with the Financial Viability of the Offeror / Supplier, and in the case of a bid submitted by a joint-venture, this information would be required by each member of the joint-venture (if requested).

Attachment B and C deal with the Technical Evaluation Criteria, which is separate and distinct from the Financial Viability of the bidder.

In Attachment B and C, only M.1 is the experience required to be met by at least one member of the joint-venture (in the case of a joint-venture) and in M.2(g)(2) is the experience required to be met by at least one member of the joint-venture. Only in these 2 cases must the experience come from an individual joint-venture member. All the remaining technical evaluation criteria can be met by the combination of experience of all the joint-venture members.

**Question 75**

Will the client be designing course content?

**Answer 75**

The scope of work for an individual client requirement will be defined in their Statement of Work, which may include a requirement for designing course content.

**Question 76**

Will the client require an individual(s) on-site?

**Answer 76**

The location of work will be defined in the Statement of Work for each individual client requirement. This may include a requirement to work at a Government of Canada site.

**Question 77**

If our partnership firm billed on a project basis, not on a per diem basis. How does this fit into the scope of these projects?

**Answer 77**

For the Standing Offer, Offerors must submit their financial bid in accordance with 1.2 Section II - Financial Bid within Component I - Part 3 - Bid Preparation Instructions.

For the Supply Arrangement, Suppliers will have to provide a financial proposal in accordance with the pricing schedule / basis of payment of any resulting bid solicitation.

**Question 78**

In Annex A Requirement of Services 3.8.0 Stream 8 - Training Delivery

Can bidders only respond to the mandatory of Instructors OR Facilitators or must they respond to both?

**Question 79**

In Annex A Requirement of Services 3.8.0 Stream 8 - Training Delivery 14 subject areas are identified upon content. Bidders must demonstrate in the mandatory qualifications for instructors their experience in the identified subject area ( from a possible 14 areas) must they also demonstrate it for ( see section 3.8.2.4)facilitators as well? The words identified subject area are not included in 3.8.2.4 Occupational Minimum Mandatory Requirements.

**Question 80**

In Annex A Requirement of Services 3.8.0 Stream 8 is it required to bid a Senior and Intermediate & a Junior Instructor or can you only bid one level?

**Answer 80**

For the Standing Offer, bidders must provide firm all-inclusive per diem rates for all levels of expertise. See Attachment D - Standing Offer Financial Evaluation for more information.

**Question 81**

In Annex E Basis of Payment ( Standing Offer Only) for Stream 8 - Instructor is directed to give rate by subject is Facilitator to do the same or a general rate for the 3 levels only?



**Answer 81**

For the Training Facilitator category, bidders are only required to provide firm all-inclusive per diem rates for the 3 levels, as there is no requirement for a Training Facilitator to be a subject matter expert, like the Instructor.
