This modification is issued to publish answers to questions received to date.

Questions (Q) and Answers (A)

- Q1. *"On page 7 of 46, Section II, 1.2 it states that unit prices submitted must include the cost of freight. Does this mean that the cost of freight is to be included in each unit price for each of the 3 shipping destinations?"*
- A1. Yes, each unit price is to include cost of freight for each of the 3 different destinations, these prices must be given in each of the three different tables (per destination), freight is not to be included in the plant pricing table.
- Q2. *"Does it mean that freight is to be charged as a separate line item to each order?"*
- A2. No, freight is not to be charged separate but be to be included in each unit item price for each of the 3 destinations. Freight is not to be included in the plant pricing table.
- Q3. *"How can a firm unit price that includes freight in that price be established for each location without a fixed order quantity?"*
- A3. It is up to the supplier to determine a reasonable freight charge per unit. No minimum quantity order will apply."
- Q4. *"On page 9 Attachment 1 to Part 3 – Pricing Schedule – a firm unit price is required to be put in but is this price excluding freight cost?"*
- A4. Yes, on page 9, Attachment 1 to PART 3, firm unit price is not to include freight cost.
- Q5. *"On page 25 Annex B – Basis of Payment – there are 3 tables – 1 for each destination and noting firm unit prices – are the prices here to include the cost of freight? How can this be established without knowing the shipping quantities for each shipment? Will there be minimum ordering quantities?"*
- A5. On page 25 Annex B, yes – as per title of table, firm unit price in Canadian dollars is to be given Carriage Paid to (CPT) for each of the 3 destinations. It is up to the supplier to determine a reasonable freight charge per unit. No minimum quantity order will apply.
