Q1: Further to our discussion, is the response to the question we submitted concerning Energy Star. We respectfully ask PWGSC to reconsider this position and modify the Energy Star and Ecologo to point rated criteria. Please note we are also requesting Ecologo be point rated. In the event this change cannot be accommodated, [we] cannot respond to this solicitation as we do not have a compliant product that meets the mandatory requirements in Category 1. While we recognize the importance of these criteria, to be eliminated from this tender for certifications of one product seems somewhat harsh.
