Delete Article 1 Evaluation Procedures under Part 4 and replace with following:

1. Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.
- (c) The evaluation team will determine first if there are three (3) or more bids with a valid Canadian Content certification. In that event, the evaluation process will be limited to the bids with the certification; otherwise, all bids will be evaluated. If some of the bids with a valid certification are declared non-responsive, or are withdrawn, and less than three responsive bids with a valid certification remain, the evaluation will continue among those bids with a valid certification. If all bids with a valid certification are subsequently declared non-responsive, or are withdrawn, then all the other bids received will be evaluated.

Delete Article 4.1 Phased Delivery under Part 6 and replace with following:

4.1 Phased Delivery

The earliest date the Contractor can start installation is within _____ calendar days from the effective date of the Contract.

Delivery and installation will be carried out on mutually agreed start dates. All work must be completed by the week of April 16, 2012 and no later than April 20, 2012.

Any changes to the above agreed installation dates and times require a minimum of 72 hours notice. Failure to provide a minimum of 72 hours notification to the Technical Authority will result in Building Access and Security charges being charged to the Contractor.

All other terms and conditions of the above referenced Solicitation remain unchanged.
