## **Addendum No. 1**

### **1. REQUEST FOR STANDING OFFER DOCUMENT**

**DELETE** Part 5 Insurance Requirments in its entirety **AND REPLACE WITH:**

#### **Part 5 Certifications and Insurance Requirements**

Offerors must provide the required certifications to be issued a standing offer. Canada will declare an offer non-responsive if the required certifications are not completed and submitted as requested. Compliance with the certifications offerors provide to Canada is subject to verification by Canada during the offer evaluation period (before issuance of a standing offer) and after issuance of a standing offer.

The Standing Offer Authority will have the right to ask for additional information to verify offerors' compliance with the certifications before issuance of a standing offer. The offer will be declared non-responsive if any certification made by the Offeror is untrue, whether made knowingly or unknowingly. Failure to comply with the certifications or to comply with the request of the Standing Offer Authority for additional information will also render the offer non-responsive.

#### **1. Certifications Precedent to Issuance of a Standing Offer**

The certifications listed below should be completed and submitted with the offer, but may be submitted afterwards. If any of these required certifications is not completed and submitted as requested, the Standing Offer Authority will so inform the Offeror and provide the Offeror with a time frame within which to meet the requirement. Failure to comply with the request of the Standing Offer Authority and meet the requirements within that time period will render the offer non-responsive.

##### **1.1 Canadian Welding Bureau Certification - Fabrication Shop**

Offerors must provide proof that the fabrication shop in which the work is to be constructed is certified by the Canadian Welding Bureau.

## 1.2 Welding Certifications - Welding Personnel

Identify all welding personnel to be used in the fabrication of the work, together with proof of their current welding qualifications and certifications under the Canadian Welding Bureau.

## 2. Insurance Requirements

The Offeror must provide a letter from an insurance broker or an insurance company licensed to operate in Canada stating that the Offeror, if issued a standing offer as a result of the request for standing offer, can be insured in accordance with the Insurance Requirements specified in **Annex B**.

If the information is not provided in the offer, the Standing Offer Authority will so inform the Offeror and provide the Offeror with a time frame within which to meet the requirement. Failure to comply with the request of the Standing Offer Authority and meet the requirement within that time period will render the offer non-responsive.

## 2. SPECIFICATION

Section 05 55 50, clause 1.4 Source Quality Control,**DELETE** “.3 Information requested under articles .1 and .1 above is to be supplied with tender documents.”
