Amendment 001

This amendment is raised to answer following questions and to extend the solicitation closing date.

Q1: What is the estimated volume of the specific garments and other items to be washed each week? We would also need to know the volume of the items to be dry cleaned as well.

A1: In terms of dollar value, it is estimated that over \$10K per month are spend on laundry. Bedspread, pillows, rags and coveralls accounts for majority of the volume and we have over 5,800 items to be laundered each month. One unit (one with the bedspreads) is estimated to send out 3,000lb of laundry every week. Pick-up/drop-offs are twice weekly on average but as there are multiple pick-up points, there might be additional pick-up/drop-offs.

Dry-cleaning on the other hand is minimal. Only the diving unit regularly uses this, estimated \$200 per month. Other units may have the occasional event that will require items to be dry-cleaned.

Q2: Could you please send me the list of items that would need to be dry cleaned?

A2: Dry Clening list is already included in the RFSO document under Annex B , Table 5, Table 6 and Table 7 (pages 24 - 26).

Q3: If the dry cleaning was sent to a subcontractor would the name of the subcontractor need to be included with the tender?

A3: Subcontractor name is not a mandatory requirement of the tender so you may or may not choose to include such information. Note in accordance with the SACC Clause A7035T identified on page 5, if requested by the Contracting Officer, you must provide those information prior to the Standing Offer award.

Q4: On Table 3, Regarding Medical. It requests that the items are sterilized. We do not have a sterilizer at our plant. What we could offer is Wash at 170 degrees, dry, fold, and wrap. Would this be expectable?
