

**1. GENERAL**

**1.1 This Addendum is issued prior to Tender closing to provide for certain revisions as noted herein.**

**1.2 All such revisions will become part of the Work and the effects shall be included in the Tender Price.**

**1.3 All work shall be performed in accordance with the Contract Documents.**

**2. SPECIFICATIONS**

**2.1 Refer to Section 01 11 00 Summary of Work Item 1.18 Permits and Licenses**

.1 Amend clause .2 as follows: “.2 A business license is required to work within Riding Mountain National Park at a cost of \$98.10.

.2 Add the following clause “.4 Truck Permits will be issued free of charge. Worker Passes for staff vehicles to permit them to be in the park during normal work hours will also be made available at no charge.”

**2.2 Refer to Section 01 11 00 Summary of Work**

.1 Add Item 1.20 Local Resources

“.1 Parks Canada Agency has compiled a partial listing of local resources available in the Riding Mountain area. This information is attached to assist the Contractors in preparation of their Bid . The Contractor is responsible to make his own assessment of the suitability and/or skill of any local resources.”

**2.3 Refer to Section 01 14 00 Work Restrictions, Item 1.3 Special Requirements**

.1 Amend clause .3 as follows: “.3 The Owner has retained a qualified biologist to examine the area for potential wildlife and vegetation species that are protected under legislation, including migratory birds with nests and /or eggs or nestlings and to develop mitigation strategies for items of concern from the pre-construction monitoring. Provide a minimum of 5 working days notice prior to any on-site work occurring for the Owner’s qualified biologist to complete pre construction monitoring. If any new species are encountered during construction, immediately notify the Department Representative and provide a minimum of 2 working days for the Owner’s biologist to review the site. If protected species at risk are identified, mitigation measures will be developed by Owner’s biologist at that time and as appropriate in consultation with the Contractor, Regulators, and Parks Canada Agency staff within 3 working days after receiving notification from the Contractor. . If nests are encountered, no on-site work shall be undertaken within 30 m of an identified nest site until otherwise approved by the Departmental Representative. Biologist retained by the Owner shall also monitor Contractor’s mitigation strategies during construction.

Amend clause .3 as follows: “.3

- .2 Amend clause .4 as follows: “.4 If a historical, archaeological, or cultural site is encountered during construction immediately stop work in the area and maintain a minimum 20 metre buffer zone around the site. Immediately notify the Department Representative and provide a minimum of 2 working days for the Owner’s archaeologist to review the site. The archaeologist will clearly mark the limits of any cultural sites encountered and develop mitigation strategies at that time and as appropriate in consultation with Contractor, Regulators and Parks Canada Agency staff within 3 working days after receiving notification from the Contractor. Archaeologist retained by the Owner shall also monitor contractor’s mitigation strategies during construction.

**2.4 Refer to Section 01 35 43 Environmental Procedures Item 1.11 Historical, Archaeological, Cultural Resources Plan**

- .1 Add the following clause “.3 A preliminary Archaeological investigation has been completed on behalf of Parks Canada Agency; no cultural materials were found during the preliminary investigation”
- .2 Add the following clause “.4 The Historical, Archaeological, Cultural Resource Plan shall be developed on the Contractor’s behalf by a Qualified archaeologist retained by the Owner. Contractor shall coordinate the development of the plan with Owner’s biologist prior to commencement of the work

**2.5 Refer to Section 01 35 43 Environmental Procedures Item 1.12 Species at Risk and Migratory Birds Protection Plan**

- .1 Add the following clause “.3 A preliminary Species at Risk report has been completed by Golder and Associates on behalf of Parks Canada Agency. A copy of the preliminary report is posted on MERX as ATT 3.”
- .2 Add the following clause “.4 The Species at Risk and Migratory Birds Protection Plan shall be developed on the Contractor’s behalf by a Qualified biologist retained by the Owner. Contractor shall coordinate the development of the plan with Owner’s biologist prior to commencement of the work.”

**2.6 Refer to Section 01 52 00 Construction Facilities Item 1.2 Site Storage/Loading**

- .1 Add the following clause “.3 Parks Canada Agency will permit the existing developed Agassiz Tower area to be utilized by the Contractor as a storage and staging area during construction.”

**2.7 Refer to Section 31 32 19.01 Geotextiles Item 2.4 Erosion control Blanket**

- .1 Add the following clause “.3 All erosion control blanket material shall be 100% biodegradeable

**2.8 Refer to Section 31 32 19.01 Geotextiles Item 2.6 Erosion control Blanket**

- .1 Delete clause .4 and replace with the following “.4 Acceptable materials shall include Second-Generation TRM: Propex Landlok TRM 300 with accessories, or suitable alternative with similar material properties as approved by the Departmental Representative.”
