M2 The Bidder must demonstrate that each proposed Senior Communication Consultant has a minimum of five (5) years experience ending at bid closing date, in providing communications services, such as: the development of a variety of communications products, briefing notes, presentations, reports, correspondence or others services / products similar to the scope of work (see Annex 'A') for the Government of Canada (including departments, boards, corporations and agencies as listed in the Schedules of the Financial Administration Act) client(s).

M3 The Bidder must demonstrate that each proposed resource Senior Communication Consultant has a minimum of five (5) years experience ending at bid closing date, in providing strategic communications advice to senior management client(s) (senior management is defined from Director level and above) the Government of Canada (including departments, boards, corporations and agencies as listed in the Schedules of the Financial Administration Act).
