TITLE: Video Animation of Route Clearance Scenarios

This amendment is raised to modify solicitation W7702-135600/A as follows:

Question 1:

We are slightly confused by some of the language/apparent criteria in the bid documentation (specifically the questionnaire - Appendix 1 to Annex C). We would like to know if DRDC is expecting compliant companies to come from Advertising agencies or film production companies?

We are a simulation company and like many in this sector are specialists in producing animated 3d models for military training purposes. As such we believe ourselves fully compliant in being able to produce scenarios and animations in the required format, output them as video, etc. in line with this solicitation. However, we wanted to ensure that although we have not sold one of our videos to an external client (see questionnaire) we would be considered acceptable under this solicitation provided we can demonstrate the required technical/artistic capability.

Answer 1:

No, DRDC is not expecting compliant companies to come from only Advertising agencies or film production companies. Bidders do not have to have shown they have sold an animation/video. Bidders should supply as much requested information as possible in order to better inform the Technical Authority, but having not produced animations under contract will not be used to assess noncompliance.

On page 21 of 37, under Statement of Work, add:

On page 37 of 37, under Appendix 1 to Annex C, PROPOSED PROJECT FACT SHEET, make the following changes:
