Question 108

Please confirm that a party that wishes to bid on future Request for Standing Offers (no yet published) need only submit a bid for Supply Arrangement.

Answer 108

It is Canada's intention to provide Suppliers with this ability. As stated in Component I - 2.5 - Refresh Bid Solicitations, each refresh solicitation stands alone, separate and apart from any previous bid solicitation.

In subsequent solicitations, Canada will outline this possibility (if permitted) similar to what is included in Component I - 2.6 Existing Offerors and Suppliers.

In this solicitation, as stated in Component I - 2.1, Bidders are able to submit a bid for the Services containing either an arrangement for a Supply Arrangement, or an offer for a Standing Offer, or both.

Question 109

Please confirm that a Supply Arrangement is sufficient pre-qualification for bidding on future RFSOs (not yet published) under the LS-SOSA.

Question 110

Please confirm that a bid for supply Arrangement (at this time) need not include a Financial Offer.
