Q6. I am inquiring about solicitation No. W3557-120024/B – Fuel Tank and Components with regards to the stairs and platform. I was wondering if a ladder and platform system would be sufficient as the company I am speaking to states a ladder and platform system is more appropriate and safety oriented due to the style and height of the tank. I have attached a drawing at ANNEX “C” of the tank for reference. Would this type of ladder and platform system be acceptable?

A6. No, a stair is required, not a ladder and it must adhere to safety regulations. Please refer to attached ANNEX “D”, however a hand rail might be required.
