**Bidders proposal must demonstrate offered bleachers meet the mandatory specifications as detailed herein:**

**Mandatory Specifications**

1. 10 row bleacher unit with seating capacity 300 persons (average weight per individual 180 lbs);
2. Bleacher unit must not exceed 10 tiers;
3. Seat planks and floorboards MUST be aluminum.
4. Unit must be rugged design, construction, and finish to withstand Manitoba Canada weather conditions (high winds and heavy snow);
5. Unit to be assembled on CFB Shilo location by supplier / manufacturer; installation **IS NOT** required;

6. All walking surfaces must have anti-slip surfaces or textured surfaces as part of the material;
7. Units must have side and top guard railing systems;
8. All stairs, ramps, access aisles will have hand railings;
9. Must have 1 access aisle with centred railing;
10. Manufacture must be Certified Canadian Welding Bureau CSA W47.1 as a minimum, and the work itself must meet CSA W59;
11. Meet CAN/CSA S16.1-94 requirements;
12. Unit must meet NBC requirements;
13. Must not be made of wood.

**Bids must include engineered stamped drawings and engineer specifications.** Submission of shop drawings and engineer specifications must clearly demonstrate to the satisfaction of the evaluation team that the goods offered meet the Mandatory Specifications.
