Question 1

We would like to know if you agree to our technical differences, in terms of functionality, the equipment will work the same:

See PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION, item 3 - Must operate on a hydraulic cylinder system (no worm drives).

Question 1.1

Operates on an electromechanical system. We use a worm drive, but we do not use Acme thread technology-our technology is different and is the safest on the market. We use a ball screw that eliminates friction, and we have an independent mechanical safety system. The only maintenance required is greasing the ball screw every 6 months.

Answer 1.1

If the system breaks down, the vehicles can be lowered slowly by gravity. The safety lock is continuously engaged; this is mandatory for safety reasons. The cylinder system does not require any maintenance (it is self-lubricating).

Question 1.2

We use a hybrid system that does not need to be connected to a power outlet when it is in use. We use two batteries in each column, and cables provide communications between each column, eliminating any risk of interference. The cables are on a reel, so they do not clutter up the floor; the cables remain suspended.

We are inquiring as to why you would be looking for a battery operated lift and whether we could offer a non-battery operated lift?

Answer 1.2

There are two reasons for choosing a wireless system:

- 1- The building where the system will be installed does not have an electrical system that will allow all eight columns to operate simultaneously.
- 2- Some large military vehicles (e.g. MSVS) require the columns to be installed outside in order to raise the vehicles to the desired level. This maintenance work is done during the summer months.
