## **PART 1 - GENERAL INFORMATION**

### **1. Security Requirement**

There is no security requirement associated with the requirement.

### **2. Requirement**

### 1. Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the Standard Acquisition Clauses and Conditions Manual (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

### **3. Enquiries - Bid Solicitation**

All enquiries must be submitted in writing to the Contracting Authority no later than ten (10) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

### **4. Applicable Laws**

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the bidders.

Canada requests that bidders provide their bid in separately bound sections as follows:

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

To assist Canada in reaching its objectives, bidders are encouraged to:

- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

#### **Section I: Technical Bid**

In their technical bid, bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

#### **Section II: Financial Bid**

Bidders must submit their financial bid in accordance with the Basis of Payment. The total amount of Goods and Services Tax (GST) or Harmonized Sales Tax (HST) must be shown separately, if applicable.

#### **Section III: Certifications**

Bidders must submit the certifications required under Part 5.

## **PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION**

### **1. Evaluation Procedures**

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

### **1.1 Technical Evaluation**

#### **1.1.1 Mandatory Technical Criteria**

Each bid will be reviewed for compliance with the mandatory technical specifications and mandatory parts of the bid solicitation. Bids that do not comply with each and every mandatory requirement will be considered non-responsive and will receive no further consideration.

- 1. The Walk-Up Instrument Platform must be easily transported, assembled and compliant with Occupational Health and Safety (OHS) codes and building codes in all Canadian provinces and territories;
- 2. The Walk-up Instrument Platform offered must meet all the Mandatory Technical Specifications and Mandatory Parts detailed in Annex "A", Requirement. The Bidder must clearly address each specification in detail demonstrating compliance to the requirement, with their bid at bid closing.

### **1.2 Financial Evaluation**

- 1. Bidders must submit pricing in accordance with Annex "A", with their bid at bid closing.
- 2. The evaluated price is the extended price, calculated by multiplying the Quantity by the Firm Unit Price offered by the Bidder.

## **2. Basis of Selection**

- 2.1** A bid must comply with all requirements of the bid solicitation to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

## PART 5 - CERTIFICATIONS

Bidders must provide the required certifications to be awarded a contract. Canada will declare a bid non-responsive if the required certifications are not completed and submitted as requested.

Compliance with the certifications bidders provide to Canada is subject to verification by Canada during the bid evaluation period (before award of a contract) and after award of a contract. The Contracting Authority will have the right to ask for additional information to verify bidders' compliance with the certifications before award of a contract. The bid will be declared non-responsive if any certification made by the Bidder is untrue, whether made knowingly or unknowingly. Failure to comply with the certifications or to comply with the request of the Contracting Authority for additional information will also render the bid non-responsive.

### 2. Certifications Precedent to Contract Award

The certifications listed below should be completed and submitted with the bid, but may be submitted afterwards. If any of these required certifications is not completed and submitted as requested, the Contracting Authority will so inform the Bidder and provide the Bidder with a time frame within which to meet the requirement. Failure to comply with the request of the Contracting Authority and meet the requirement within that time period will render the bid non-responsive.

#### 2.1 Federal Contractors Program - Certification

Suppliers who are subject to the Federal Contractors Program (FCP) and have been declared ineligible contractors by Human Resources and Skills Development Canada (HRSDC) are no longer eligible to receive federal government contracts over the threshold for solicitation of bids as set out in the Government Contracts Regulations. Suppliers may be declared ineligible contractors either as a result of a finding of non-compliance by HRSDC, or following their voluntary withdrawal from the FCP for a reason other than the reduction of their workforce to less than 100 employees. ## ANNEX "A" REQUIREMENT

### Walk-up Instrument Platform

#### 1. Summary

Environment Canada (EC), Toronto, ON, requires the provision of five (5) walk up instrument platforms to perform air quality monitoring testing. The design of the walk up instrument platform must be easily transported, assembled and compliant with Occupational Health and Safety (OHS) codes and building codes in all Canadian provinces and territories. To achieve the intended design, standard scaffolding members in a pre-configured design are required.

#### 2. Mandatory Technical Specifications

- 2.1 The working platform must be at least 13 feet in height with an upper platform/deck of 8' x 17' (8' x 8'6" deck with an 8' x 8'6" end extension). All platforms and stairs must be surrounded by safety railings compliant with OHS and building codes. The material used in all components must be galvanized steel. All connectors must interconnect the components with removable clamping mechanisms, not welded to each other. The base of the platform must be adjustable using screw/swivel jacks to help with levelling. Levelling must have at least an 18" range;
- 2.2 The overall load rating must meet or exceed 50 lbs per square foot;
- 2.3 Parts listed at Section 3, Mandatory Parts, must assemble to the configuration as shown in Sections 1.1 and 1.2, Platform Design, Appendix A to Annex A;
- 2.4 All parts for each walk up instrument platform must be packaged as one unit for shipment and assembly on site. No sorting and/or re-packaging of parts are to be required for re-shipment of platforms to separate installations/assembly points;
- 2.5 All components must be clearly labelled or colour coded;
- 2.6 All parts including removable clamps must be included for each instrument platform;
- 2.7 The complete walk up instrument platform must be designed to allow assembly by a minimum of two people.


