PART A - QUESTIONS AND ANSWERS

This question applies to RFSO EN578-093429/D

Question 10

Could you check and correct certain tables indicating the place of training for streams 5 and 6?

Example : Part 1 General Information, Summary stream 5 = at a Federal institution, stream 6 = on the Offeror's premises

article 2.2.1 stream 5 =at a Federal institution, stream 6= on the Offeror's premises

In pricing schedule : stream 5=on the Offeror's premises ?, stream 6=at a Federal institution ?

At article 2.2 Basis of Selection : stream 5 at a Federal Institution ?, stream 6 on the Offeror's premises ?

Answer 10

Question 11

This question applies to RFSO EN578-093429/C

p. 74, article 9.4.1 OIV

Could you specify the number of resources that you require to conduct these interviews: one or two?

Answer 11

Only one resource is needed to administer an OIV.

Question 12

This question applies to RFSO EN578-093429/C

p. 43, article 6.1.2.6

With respect to the Offeror's deadline for advising the Project Authority of its capacity to carry out the Work, could you extend this deadline by one or two business days, because forming groups, assigning teachers and assigning classrooms, etc. takes time?

Answer 12

The purpose of the one-day deadline is merely to notify the IU's Project Authority if the Offeror is not able to perform the Work. Deadlines for forming groups and assigning resources, etc. are longer.

Question 13

p.27, PRTC 2.2.2.

Points awarded for the method used: How will you do the calculation for an adviser/teacher who has taught a number of hours using PBFT and a number of hours using PFL₂? Since PFL₂ has only been in the marketplace since 2006, we suggest that 10 points be awarded for it if the Offeror has been using PFL₂ since 2006. The Offeror should not be penalized for what was done prior to 2006 because PFL₂ was not available at that time.

Answer 13

As indicated in PRTC 2.2.2 B), if the Offeror has demonstrated that it has experience with more than one training program in response to PRTC 2.2.2, points will be awarded for the program earning the highest number of points but not for a combination of programs. In the example provided in question 13, the offer may receive 10 points.

Question 14**This question applies to RFSO EN578-093429/C**

MTC 1 Offeror's Capacity

You require that the capacity be a multiple of 5. Could this condition be withdrawn to give greater flexibility to schools that, for example, have the capacity to offer 12 classes at the same location?

Answer 14

No change to the RFSO is made.

Question 15**This question applies to RFSO EN578-093429/D**

Technical Criterion PRTC 3 article 1.1.2 Offeror's Facilities

This criterion does not apply to streams 4 and 6 because the courses are given at federal institutions. Could you provide another scoring grid for streams 4 and 6 only?

Question 16

This question applies to RFSO EN578-093429/D

MTC 1 Offeror's Capacity for stream 3 A

You are requiring a minimum of 10 classrooms, based on the knowledge that one classroom can accommodate 10 part-time groups, and you intend to award three standing offers. Aren't your assumptions too optimistic? Couldn't you reduce this to two or three large classrooms for this stream? We know through experience that part-time training is preferably given on departments' premises in order to avoid time-consuming travel. What's more, individual departments already have a number of standing offers to meet their own particular requirements.

Answer 16

No change to the RFSO is made.

Question 17

PRTC 2.2.2 - 2nd column, a) "by the proposed pedagogical adviser" should be replaced by "by the proposed teacher" because it is the teacher who is being evaluated.

Question 18

PRTC 2.2.2 Backup Adviser (experienced teacher)

For a teacher with over 9,000 hours of teaching experience, we can provide: a) the number of hours per year since 2002, and b) the number of learners, but calculating the number of weeks and the number of hours of training per student would be an arduous, virtually impossible task; we would have to search through 10 years of files, and the applicable government references are no longer available! Could you change this requirement and, as with PRTC 2.2.3 c), ask for the start and end dates for each year, with one reference per year of experience up to a maximum of three references?

Question 19

With respect to the answer given to question 2 in Amendment 001:

- 1) How long will the Offeror have between the announcement of the successful offerors and the start of the Work to fit up other classrooms if the Offeror has proposed the same classrooms for two different streams?
- 2) Could you confirm whether the Offeror may propose the same backup adviser for the three offers (C, D, E) if it proposes a single primary adviser for each offer?

Answer 19

1) Canada cannot determine in advance the number of days that it will need to evaluate the offers received in response to the RFSO. Furthermore, it cannot provide the start and end dates of the Work, as the training will be provided when requested by Identified Users (IUs). However, as is indicated in MTC 1: Offeror's Capacity, the Offeror must have the number of classrooms indicated in its offer throughout the duration of the standing offer and the resulting call-ups.

2) Yes, provided it complies with the ratio required for each work stream in respect of which it submits an offer.

Question 20

In item 2.3.1 of MTC 2, you ask for a copy of the original equivalency certificate certified as true. Is a copy certified by a notary or lawyer acceptable? And does a certified copy have to be included with each copy of an offer?

Answer 20

Yes, a copy certified by a notary or a lawyer is acceptable.

If you are referring to each of the Requests for Standing Offers (RFSO), a certified copy must be attached to each RFSO.

If you referring to article 1.1 of PART 3 - OFFER PREPARATION INSTRUCTIONS, a single certified copy may be provided in response to the work stream(s) included in the same RFSO.

Question 21

In MTC 2, item 1. a), of 2.3.1, do you require the names of at least two teaching resources that have been supervised, or do you want details of their teaching experience over a period of at least one year?

Answer 21

The information required is listed in 2.3.2.

Question 22

This question applies to RFSOs DOC EN578-093429/C and EN578-093429/E.

We currently have a primary pedagogical adviser and a backup pedagogical adviser working with and supervising the same groups, individuals and teaching resources. Can these two advisers use the same groups, individuals and teaching resources to describe their experience?

Answer 22

No, because backup pedagogical advisers cannot have supervised the same groups or individuals as the primary pedagogical adviser at the same time.

Question 23

This question applies to RFSO EN578-093429/C

In PRTC 2.1.2, we understand that you would like to evaluate the experience of the proposed pedagogical adviser (teacher), but the criteria focus on the number of weeks and hours of training received by the students; for example, you have indicated that a full-time course is equivalent to 16 consecutive weeks and a minimum of 30 hours per week. Like all other language schools, our teachers teach two learners per day (morning/afternoon) on a full-time basis, which works out to 17.5 hours per week for each learner, for a total of 35 hours per week for the teacher. The criterion of 16 consecutive weeks and 30 hours per week for the learners will automatically eliminate a teacher with experience teaching 35 hours per week. Will you consider this teacher as having taught full time? Or, could you amend the requirements so they focus on the hours taught rather than the hours of training received by the learner?

You have also added a statement indicating that training for 32 consecutive weeks cannot be divided, which limits the chances of teachers who have taught long sessions.

Question 24

In PRTC 2.1.1, we have courses for international students, who are not federal employees, at 30 hours per week using a CSPA program.

Is this experience considered valid experience for pedagogical advisers?

Answer 24

Yes, provided that the courses meet the criteria.

Question 25

We would like to discuss the Familiarization Sessions on the PFL². If instructor has already been teaching PFL² could there be a shorter version of this course. For example 2 days instead of 5 days.

Answer 25

No, because the content of the new Familiarization Sessions is different. The Canada Shchool plans to offer a part of the Familiarization Sessions on an e-learning basis.

Question 26

If we would like to propose a pedagogical adviser with more than 15 years of experience teaching federal employees in various schools and we do not have any information on this teacher's previous experience besides the number of hours taught, would you consider the number of teaching hours as sufficient experience for the purposes of this RFSO?

Réponse 26

Only offers containing all the information required for each criterion will be considered and evaluated for these RFSOs.

Question 27

This question applies to RFSO EN578-093429/D

Work streams 3A and 3B

For work streams 3A and 3B, based on our understanding of the area, schools located in downtown Gatineau may qualify for both stream 3A and stream 3B, while all other schools, whether in downtown Ottawa, in the east or in the west, may only qualify for one work stream.

Therefore, we request that you amend the boundary for stream 3A so it covers only downtown Ottawa and the boundary for stream 3B so it covers only the Outaouais region, or that you consolidate streams 3A and 3B so all schools are subject to the same rules and are unable to qualify for more than one work stream based on the geographic location of their facility.

Answer 27

As indicated in article 10.0 of Section I of the Annex A - Statement of Work, the territories for each work streams 3A, B, C and D are defined as follows:

Stream 3A : within the following boundaries: between Wellington Street, Maclaren Street, Bay Street and Elgin Street in Ottawa, Ontario and between Laurier Street, Sacré-Cœur Boulevard and St-Rédempteur Street in Gatineau, Quebec.

Champ 3B : within a 10 km radius from the center of the river behind the library of the Parliament Building on Wellington Street, Ottawa, Ontario, in the Outaouais, in the Quebec province, except for the predefined area in stream 3A.

Champs 3C : within a 10 km radius from the center of the river behind the library of the Parliament Building on Wellington Street, Ottawa, Ontario, in the East area of the Ontario province, except for the predefined area in stream 3A.

Champs 3D : within a 10 km radius from the center of the river behind the library of the Parliament Building on Wellington Street, Ottawa, Ontario, in the West area of the Ontario province, except for the predefined area in stream 3A.

As indicated in article 1. **Offer Preparation Instructions of PART 3**, the Offeror may submit one or more work streams. In the event that the Offeror submits an offer for more than one work stream, the Offeror may qualify for each of the work streams for which it has submitted an offer.

Question 28

Bidder's Conference

You are planning on holding two separate conferences for Offerors: one in French and one in English. In the spirit of federal bilingualism and especially considering the expertise of language training schools in both official languages, we request that you combine the two conferences and present one single **bilingual** session that will address issues in both official languages and therefore provide offerors with the same information. Otherwise, you are somewhat forcing offerors to attend both sessions to ensure that they receive all the information requested and provided, and to participate in the discussion that takes place.

Answer 28

Two presentations will be offered, one in French and one in English.

Question 29

This question applies to RFSO EN578-093429/C

Stream 2 - Group in English

You indicate that offerors must submit a proposal for a minimum of 10 groups. Your estimates suggest that only 37 learners will receive training in English every 12 months. The chances that 10 groups will receive training are therefore very slim if we consider that Identified Users might change their plans. Please provide us with the number of groups that received full-time training in English from the CSPS in the last three years before the training centre closed its doors. We also ask that you lower the number of groups for which a school can submit an offer to a number of the school's choice or at least to 5, given the high risk to offerors of having a large number of empty classrooms for stream 2 if they have to provide for a minimum of 10 groups.

Answer 29

There were approximately 20 groups at Asticou. However, this is not representative of the total number of groups trained in the departments.

The reason why there are so few learners in the estimates for full-time group training is that there were no SOs or contracts to provide group training in English. We are hoping that for this RFSO, there will be responsive offers for this work stream, which would enable us to provide full-time group language training in English.

As indicated in section 2.2.1, PART 1, of the RFSO, the inclusion of volumetric data in this document is done in good faith and does not represent a commitment by Canada with respect to its future use of SOs. The actual number may be higher or lower than the estimate. Given that the number of learners is limited to a minimum of 3 and a maximum of 6, the required minimum number of groups is justified.

No change to de RFSO is made.

Question 30

This question applies to RFSO EN578-093429/C. This question also applies to the other streams for which the RFP indicates experience in French or in English.

Work Streams 1 and 2

We understand that you intend to award 6 standing offers for full-time courses in French and 1 standing offer for full-time courses in English. The criteria include both French and English, which is somewhat confusing and can be interpreted in a number of ways. Could you please confirm that the requirement to qualify in French is **experience in teaching French** and that the requirement to qualify in English is **experience in English**. More specifically, if the Offeror submits a proposal for stream 1, must the experience indicated be strictly in teaching French and for stream 2, strictly in teaching English? Or can the experience be a combination of the two languages?

In order for an adviser to qualify, it seems that there are several indications that the experience of the proposed resource must have been acquired in the teaching language of the specific work stream, meaning either in French or in English.

Please clarify the exact content required to meet this criterion.

Answer 30

The experience can be in either language, meaning that it can be in French or in English or in a combination of the two languages.

Question 31

This question applies to RFSO EN578-093429/C

Use of the PFL2 - Work streams 1 and 2 - Criterion PRTC1.1 (page 20)

For this criterion, you ask the offerors to indicate the number of years of experience they have acquired since January 2000. Given that PFL₂ was not officially published and used until 2006 and that the CSPS used PBFT prior to 2006, it would seem that no school can score 10 points—they will all score 5 points. Can you explain the link between January 2000 and the publication of PFL₂ in 2006, and explain why schools that used PBFT until 2006 but have since used PFL₂ will be penalized 5 points?

Answer 31

Question 32

This question applies to RFSO EN578-093429/C

Computer Equipment provided by the Supplier - Criterion PRTC3.2 (page 031)

For work streams 1 and 2 (page 29), will PWGSC allow the contractors to have the learners sign accountability agreements concerning their custody and care of the computer equipment that will be lent to them?

Answer 32

Contractors will not be permitted to have learners sign accountability agreements.

Question 33

This question applies to RFSO EN578-093429/C

Parking Lot disponibility - Criterion PRTC4.2 (page 31)

Under PRTC 4.2, you award points for free and paid parking facilities. We deem this criterion to be discriminatory, given that it has absolutely nothing to do with the language training services to be provided. Given that the geographic locations and distances have already been determined, this criterion does not seem appropriate. The RFP seems to strongly favour schools situated outside downtown Ottawa, which consequently pay lower rent. We request that you award the same number of points for free and paid parking, as long as sufficient spaces are available to meet the needs of the people who choose to attend the course. In general, when the federal government sends its employees on training (regardless of the type of training), parking is not generally one of the point-rated criteria used to award contracts to companies, and the government employees are responsible for covering the cost of parking.

Question 34

This question applies to RFSO EN578-093429/C

Daylight - Criterion PRTC4.4 (page 32)

Could you please explain what you mean by direct access to daylight? For example, daylight could mean windows in the classroom, but it could also mean direct, but diffuse, light that enters through a window, passes through a hallway, filters through a door, and so on. Please clarify.

Answer 34

Direct access to daylight means unobstructed access. Indirect access to daylight by way of another room that has direct access is not acceptable.

Question 35**Cost per student**

It is difficult, if not impossible, to set a price per participant if you do not know in advance how many learners there will be in the group (based on the number of registrations for a given step). You want the schools to provide a price, which might vary from 50% to 100%, depending on the number of learners (3 to 6) in the group.

If, for example, a supplier sets its rate at \$30 per hour, here are the possible scenarios: three learners = \$10 per learner, four learners = \$7.50 per learner, five learners = \$6 per learner, six learners = \$5 per learner. As you can see, the price varies greatly and could create major financial issues for the supplier. Should the price be based on three, four, five or six learners in a group?

As indicated in our letter of interest and by many other schools, it is very important that the rules of the game be the same for all the schools. The current financial proposal requires the schools to guess how many learners will be in a group. This could have negative effects on both the learners and the schools, who are asked to pull numbers out the air.

We therefore suggest the following two options for setting prices that are fairer and more equitable for all offerors:

- a. Ask the offerors to submit an hourly rate.
- b. Ask the offerors to submit a price for an **actual number** of participants, that is, one price per learner for three learners, another price per learner for four learners, and so on. That way, if there are three learners in the group, the price quoted for three learners will be billed; if there are four learners in the group, the price quoted for four learners will be billed, etc.

These options will require new calculation formulas, but we truly believe that using one of these options is the only way for PWGSC to fairly evaluate the financial proposals and place the suppliers on an even playing field where they can prepare their financial proposals according to the same rules.

We therefore request that PWGSC revise the terms and conditions of the required financial proposal for all work streams.

Answer 35

No change to the RFSO is made.

Question 36

Closing date—reasonable and adequate preparation time compared with evaluation time

Given that we still have at least 10 other questions and that the bidders' conference will not take place until November 22, we will have barely three weeks after that to complete our submission of proposals for the various work streams. Because a number of sections in our offers cannot be completed until our questions are answered, we request that you change the RFP closing date to January 15 (to take the holiday season into account).

The RFP is long and complex. The government required a number of years and committees to prepare it, and we have been sending our comments on this subject to PWGSC and other parties for over a year now. We do understand, however, PWGSC's desire to award the standing offers by April 1.

Nonetheless, because private companies have been given the period of October 31, 2012, to December 14, 2012, to prepare their offers (six weeks), we believe that it would be much fairer if PWGSC gave us one month more, that is, two and a half months to prepare our offers. This amount of time would be equal to the amount of time PWGSC will take to evaluate the offers (two and a half months for the schools to prepare their proposals and two and a half months for PWGSC to evaluate the offers).

We hope that you will be open to this very reasonable request on the part of the suppliers, who have their work cut out for them.

Answer 36

The closing date of the RFSOs remained unchanged.

Question 37

I will want clarification around the financial piece. I understand that per hour per learner works easily to bill back to departments or to JV the invoice, but from my perspective, I need to ensure that I cover my costs on the minimum number of participants, so the Crown is arguably not getting the best value. I would also like to understand invoicing practices. Will each call-up come from PWGSC for a whole group or will we have to invoice each participant's organisation separately with a unique contract number per person? This is an ongoing issue with EN578-090378 - not with PWGSC, but the identified users, so I'd like to know ahead of time as it has an impact on the rate.

Answer 37

This question applies to RFSO EN578-093429/C and DOC EN578-093429/D

The minimum number of learners for each work stream is indicated in each Request for Standing Offer (RFSO), in Attachment 1 to PART 3 and in article 3.3 of Section II of Annex A - Statement of Work.

This question applies to RFSO DOC EN578-093429/C, EN578-093429/D and EN578-093429/E.

All Identified Users (IUs), including PWGSC, will proceed in the same fashion. IUs will be able to issue a call-up for one or more learners and/or group classes. The Offeror will have to submit the invoice(s) in accordance with the instructions provided in article 5 - Invoicing Instructions, set out in Part 7B of each RFSO.
