Amendment #1

Please note the following clarification information:

1. The determined price for a call up will be based on an estimate. Each individual call up will be inspected by the winning vendor and DND will receive the cost estimate for repairs. At that point DND will determine whether to proceed with the repair at the vendors estimated cost or not.

To further clarify our position with regards to "is the job completed and invoiced". DND will not be held to a yearly maximum cost for body&paint repairs. DND will only allow a call up to proceed when DND has determined the cost effectiveness of each individual call up. The annual limit is just a cap or maximum on what DND will spend, not a guarantee of what the total annual spending will be.

2. For estimate purposes the number of call-ups per year is expected to be (approximately) 32 - 40. Historically this put the "average" contract at \$2500.

3. The solicitation closing date has been extended until 18 January 2012.

All other terms and conditions remain unchanged.
