Annex B states that the selected contractor will be paid on an all-inclusive hourly rate; however, the table in Annex D has a category of personnel for both adjusters and administrative support. An all-inclusive rate would include both of these salaries, as well as several other costs and considerations. If we attempt to separate out the costs from the all-inclusive rate for the purposes of this table the evaluation would no longer be based on the rates that PWGSC
