**A31** DRDC will provide and control the cryptographic equipment throughout the project.

**Q32** *What support will DRDC provide to the contractor's Arctic Trial technical support team traveling to Gascoyne Inlet (Task 7)? For example, will DRDC provide transportation, accommodation, meals and so forth or will bidders need to price these items into their bid? Will DRDC provide a climate-controlled enclosure or building for the ASDS equipment racks, or does the contractor need to use outdoor-rated enclosures? Will DRDC provide electrical power for the ASDS at the Northern Test Site?*

DRDC will provide a heated building and diesel generator produced electrical power. DRDC will provide a satellite communications system. The contractor will provide all Uninterruptable Power Supplies (UPS) that it considers necessary for power conditioning and power failure reaction for his design. DRDC will provide fibre optic communications between buildings.

The contractor will be responsible for transportation of his field staff to and from Resolute/home and for accommodation while in Resolute. DRDC will provide transportation between Resolute and the Arctic site. DRDC will provide meals and accommodation on site. Accommodation at the site is austere and will be in shared bunk houses. The camp will provide wash rooms, showers and access to a clothes washer. Field staff will be required to have sleeping bags rated for -5 degrees Celsius
